Subject: Grant Application for Gwen Cherry Park Aquatic Center

Recommendation

It is recommended that the Board approve the attached resolution authorizing the County Mayor or his designee to apply for up to \$200,000 in grant funds from the Florida Department of Environmental Protection, Land and Water Conservation Fund to renovate the Gwen Cherry Park Aquatic Center.

Scope

The Gwen Cherry Park Aquatic Center is located at 2591 N. W. 71 Street, in Commission District 2.

Fiscal Impact/Funding Source

This grant will contribute \$200,000 toward the \$850,000 cost of constructing improvements to the aquatic center. The grant match will come from two sources: \$325,000 from the Safe Neighborhood Parks Bond Program and \$325,000 from the Quality Neighborhood Improvement Program.

Track Record/Monitor

In the last 5 years, the Land and Water Conservation Fund Program has awarded the Park and Recreation Department two grants, \$200,000 in 2003 for the Biscayne Jetty Trail and \$200,000 in 2004 for the Haulover Promenade Trail. This year the grant program is expected to be meagerly funded. The new grant, if awarded, will be administered by Joyce Denny, Grants Administrator in the Park and Recreation Department.

Background

On behalf of the U. S. Department of the Interior - National Park Service, the Florida Department of Environmental Protection through the Land and Water Conservation Fund Grant program provides competitive grants to local governments to acquire and develop land for public outdoor recreation. The grant application deadline is February 15, 2008. If the application is successful, the grant will be awarded sometime between September and December 2008.



RESOLUTION APPROVING SUBMISSION OF GRANT APPLICATION FOR UP TO \$200,000 IN GRANT FUNDS FROM THE FLORIDA DEPARTMENT OF ENVIRONMENTAL PROTECTION, LAND AND WATER CONSERVATION FUND TO RENOVATE THE GWEN CHERRY PARK AQUATIC CENTER AND FURTHER AUTHORIZING THE COUNTY MAYOR OR HIS DESIGNEE TO ACCEPT, EXPEND FUNDS, AND EXECUTE CONTRACTS AND AMENDMENTS AS REQUIRED

WHEREAS, this Board desires to accomplish the purpose outlined in the accompanying memorandum, a copy of which is incorporated herein by reference,

NOW, THEREFORE BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board authorizes submission of a grant application for up to \$200,000 in grant funds from the Florida Department of Environmental Protection, Land and Water Conservation Fund to renovate the Gwen Cherry Park Aquatic Center; and further authorizes the County Mayor or his designee to execute such contracts and amendments as are required by this governmental body following approval by the County Attorney's Office; to receive and expend all monies for the purposes described in the funding request; and to file and execute any necessary amendments to the agreement for and on behalf of Miami-Dade County, Florida.
