RESOLUTION NO. R-1148-08

RESOLUTION APPROVING THE WAIVER OF PLAT OF VALERIE MEAD AND GODFREY MEAD, D-22533, LOCATED IN THE SOUTHEAST 1/4 OF SECTION 13, TOWNSHIP 52 SOUTH, RANGE 41 EAST (BOUNDED ON THE NORTH BY NE 158 STREET, ON THE EAST BY APPROXIMATELY NE 2 AVENUE, ON THE SOUTH BY APPROXIMATELY NE 156 STREET, AND ON THE WEST BY NORTH MIAMI AVENUE)

WHEREAS, Valerie Mead, a married woman, and Godfrey Mead, a single man , have this day presented to this Board a waiver of plat of certain lands lying in Miami-Dade County, Florida, said waiver of plat of the property legally described as a portion of Lot 211 of "Biscayne Gardens Section A", according to the plat thereof, as recorded in Plat Book 40, at Page 41, of the Public Records of Miami-Dade County, Florida, lying and being in the Southeast 1/4 of Section 13, Township 52 South, Range 41 East, Miami-Dade County, Florida, and it appears that all requirements of law concerning said waiver of plat insofar as the authority of this Board is concerned have been complied with,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that said waiver of plat is hereby approved; that the property has been found to be in compliance with Chapter 28 Subdivision of Miami-Dade County Code; that approval of this waiver of plat is not a waiver of any zoning regulations and that the requirements of the zoning existing on this land at the time this resolution is approved shall be enforced whether or not the parcel on this waiver of plat conforms to those requirements; this approval is conditioned upon the proper execution of all documents required by the County Attorney's Office.

The foregoing resolution was offered by Commissioner **Sally A. Heyman** who moved its adoption. The motion was seconded by Commissioner **Katy Sorenson** and upon being put to a vote, the vote was as follows:

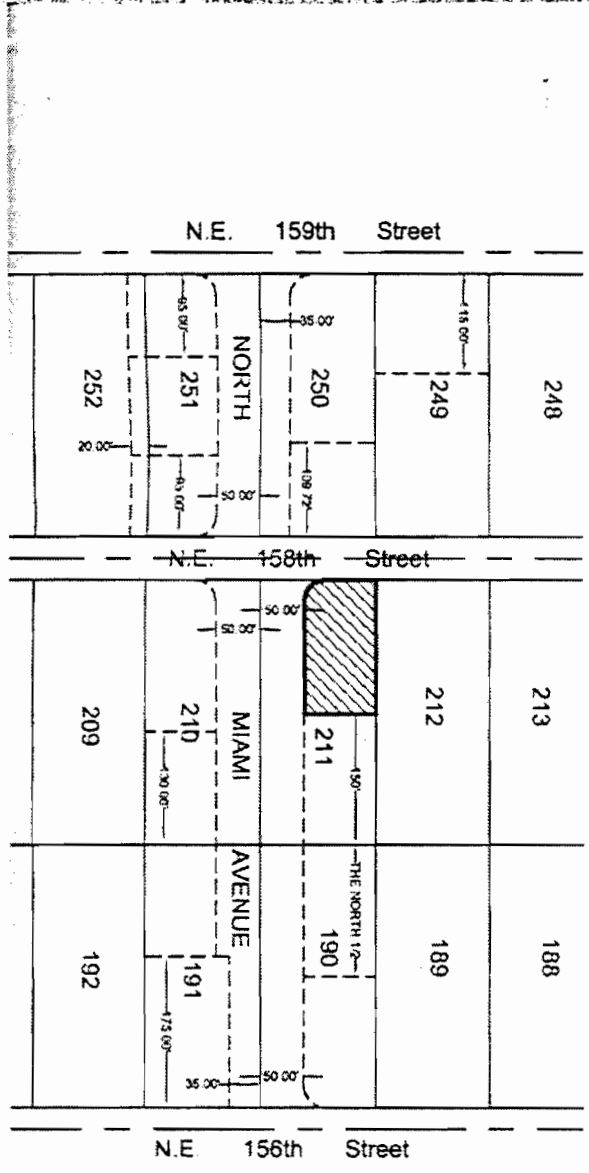
