

RESOLUTION APPROVING THE WAIVER OF PLAT OF ISMAEL VALDES AND AMNERIS VALDES, D-22936, LOCATED IN THE SOUTHWEST 1/4 OF SECTION 28, TOWNSHIP 54 SOUTH, RANGE 40 EAST (BOUNDED ON THE NORTH BY APPROXIMATELY SW 66 STREET, ON THE EAST BY APPROXIMATELY SW 93 AVENUE, ON THE SOUTH BY SW 68 STREET, AND ON THE WEST BY SW 94 AVENUE)

WHEREAS, Ismael Valdes and Amneris Valdes, husband and wife, have this day presented to this Board a waiver of plat of certain lands lying in Miami-Dade County, Florida, said waiver of plat of the property legally described as a portion of Tract 85 of "Dade County Development Company's Subdivision", according to the plat thereof, as recorded in Plat Book 3, at Page 169, of the Public Records of Miami-Dade County, Florida, lying and being in the Southwest 1/4 of Section 28, Township 54 South, Range 40 East Miami-Dade County, Florida, and it appears that all requirements of law concerning said waiver of plat insofar as the authority of this Board is concerned have been complied with,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that said waiver of plat is hereby approved; that the property has been found to be in compliance with Chapter 28 Subdivision of Miami-Dade County Code; that approval of this waiver of plat is not a waiver of any zoning regulations and that the requirements of the zoning existing on this land at the time this resolution is approved shall be enforced whether or not the various parcels on this waiver of plat conform to those requirements; this

approval is conditioned upon the proper execution of all documents required by the County Attorney's Office.

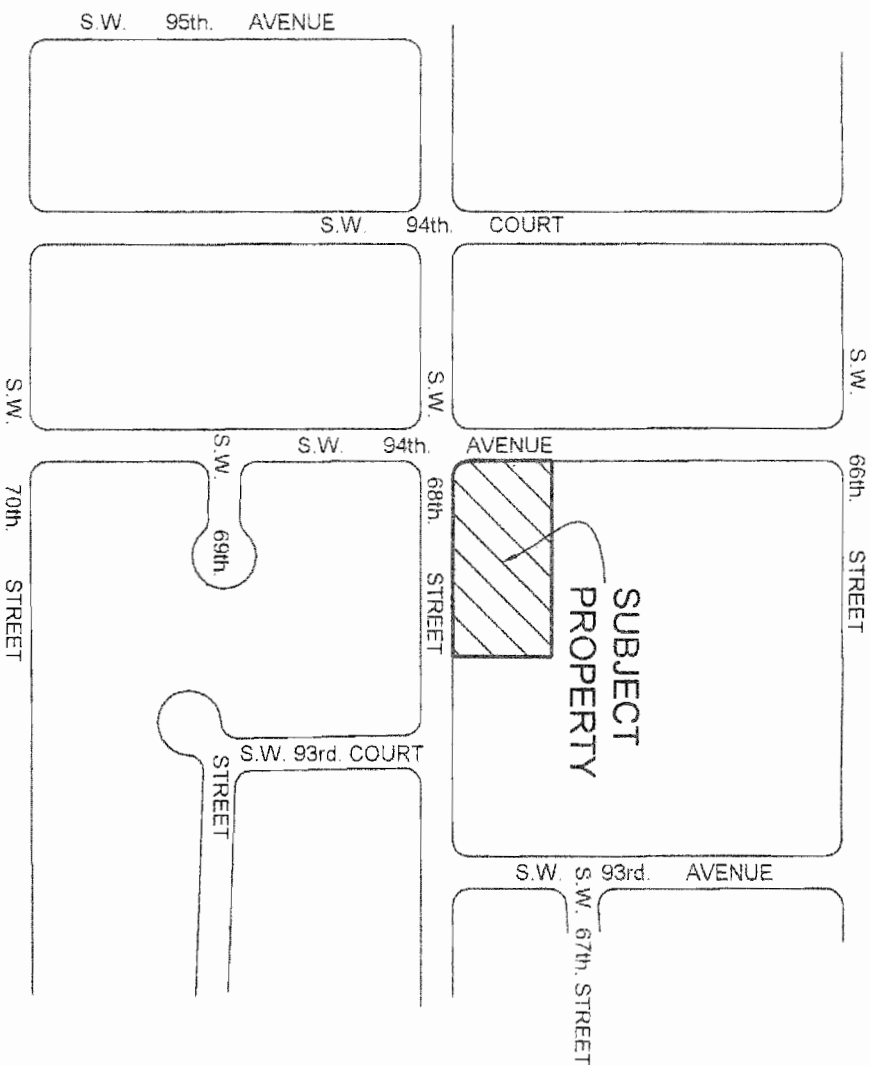
