**RECOMMENDATION**

The following plat meets concurrency and is hereby submitted for consideration by the Board of County Commissioners for approval. The Miami-Dade County Plat Committee recommends approval and recording of the plat listed below. This plat is bounded on the north by NW 17 Street, on the east by NW 132 Avenue, on the south by NW 14 Street, and on the west by approximately NW 137 Avenue.

**BACKGROUND**

BEACON LAKES NORTH (T-22766)

- Located in Section 35, Township 53 South, Range 39 East
- Commission District: 12

- Proposed Usage: Warehouses

**PLAT RESTRICTIONS**

- That the Streets and Avenue, as illustrated on the plat, together with all existing and future planting, trees, shrubbery and fire hydrants thereon, are hereby dedicated to the perpetual use of the public for proper purposes, reserving to the dedicators, their successors or assigns, the reversion or reversions thereof whenever discontinued by law.
- That individual wells shall not be permitted within this subdivision, except for swimming pools, sprinkler systems and/or air conditioners.
- That the use of septic tanks will not be permitted within this subdivision, unless approved for temporary use, in accordance with County and State regulations.

- That all new electric and communication lines may be installed overhead, service conductors from the pole to the building (structure) shall be an underground service lateral.
- That the drainage and utility easements, as illustrated on the plat, are hereby reserved for the installation and maintenance of drainage facilities and public utilities.
- That the utility easements, depicted by dashed lines on the plat, are hereby reserved for the installation and maintenance of public utilities.

**DEVELOPER'S OBLIGATION**

- Paving, drainage, sidewalks, striping and monumentation. Bonded under bond number 7811 in the amount of \$16,848.00.



RESOLUTION APPROVING THE PLAT OF BEACON LAKES NORTH, LOCATED IN THE SOUTHWEST 1/4 OF SECTION 35, TOWNSHIP 53 SOUTH, RANGE 39 EAST (BOUNDED ON THE NORTH BY NW 17 STREET, ON THE EAST BY NW 132 AVENUE, ON THE SOUTH BY NW 14 STREET, AND ON THE WEST BY APPROXIMATELY NW 137 AVENUE)

**WHEREAS**, Beacon Lakes Community Development District, an independent local unit of special purpose government, and Mobis Parts America, LLC, a Delaware limited liability company, have this day presented to this Board a plat of certain lands lying in Miami-Dade County, Florida, said plat to be known as BEACON LAKES NORTH, the same being a subdivision of a portion of land lying and being in the Southwest 1/4 of Section 35, Township 53 South, Range 39 East, Miami-Dade County, Florida, and it appears that all requirements of law concerning said plat insofar as the authority of this Board is concerned have been complied with,

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA**, that said plat is hereby approved; that the dedication of the streets, alleys and other rights-of-way however designated or depicted on said plat is hereby accepted; that the Miami-Dade County Plat Restrictions as listed on said plat are approved and are to be enforced; that approval of the plat is not a waiver of any zoning regulations and that the requirements of the zoning existing on this land at the time this resolution is approved shall be enforced whether or not the various parcels on this plat conform to those requirements; this approval is conditioned upon the proper execution of all documents required by the County Attorney's Office.
