Subject: Resolution Ratifying Submission of a Grant Application to the National Oceanic and Atmospheric Administration (NOAA) in the Amount of \$1,967,093 for Marine Habitat Creation in the Coastal Waters of Miami-Dade County

Recommendation

It is recommended that the Board adopt the attached resolution ratifying the submission of a grant application to the NOAA in the amount of \$1,967,093 for the creation of benthic marine habitat in the coastal waters of Miami-Dade County (Attachment A) from funds that may be available through the American Recovery and Reinvestment Act.

Scope

The habitat creation will occur in the nearshore regions off Commission Districts 5 and 7. The areas are jurisdictional waters of the state, and serve recreational and commercial interests of County residents, businesses and visitors. The project impact is countywide.

Fiscal Impact/Funding Source

If awarded, the grant will contribute \$1,967,093 toward the estimated total project cost of \$2,049,103 from funds that may be available through the American Recovery and Reinvestment Act. The voluntary match of \$82,010 is available from the Biscayne Bay Environmental Enhancement Trust Fund, from the Building Better Communities General Obligation Bond Program and from in-kind services.

Track Record/Monitor

The Director of the Department of Environmental Resources Management will monitor this grant.

Background

Miami-Dade County's natural and artificial reef resources provide much environmental and economic benefit to the County. For example, the related recreational activities such as boating, fishing and diving in Miami-Dade County had an economic impact estimated at \$1.297 billion in 2000-2001.

The creation of new habitat through placement of artificial reefs will enhance the coastal benthic habitats and tourism by providing additional recreational opportunities and support for tourism-related businesses. Through the "American Recovery and Reinvestment Act of 2009," funding was appropriated to the National Oceanic and Atmospheric Administration for 'shovel-ready' habitat restoration and enhancement projects. This project will provide for creation and enhancement of benthic habitat, serve to benefit the marine construction industry, and enhance the diving and fishing opportunities and businesses within the County.

RESOLUTION RATIFYING SUBMISSION OF A GRANT APPLICATION TO THE NATIONAL OCEANIC AND ATMOSPHERIC ADMINISTRATION IN THE AMOUNT OF \$1,967,093 FOR MARINE HABITAT CREATION IN THE COASTAL WATERS OF MIAMI-DADE COUNTY; AUTHORIZING THE MAYOR OR THE MAYOR'S DESIGNEE TO RECEIVE AND EXPEND GRANT FUNDS; AUTHORIZING THE MAYOR OR THE MAYOR'S DESIGNEE TO APPLY FOR ADDITIONAL GRANT FUNDS; AUTHORIZING THE MAYOR OR THE MAYOR'S DESIGNEE TO EXERCISE AND EXECUTE APPLICATIONS, CONTRACTS, AGREEMENTS, MEMORANDA OF UNDERSTANDING, AMENDMENTS, MODIFICATIONS, TERMINATION AND CANCELLATION CLAUSES, AFTER APPROVAL BY COUNTY ATTORNEY'S OFFICE

WHEREAS, this Board desires to accomplish the purposes outlined in the accompanying memorandum, a copy of which is incorporated herein by reference,

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board hereby ratifies the submission by the Mayor or the Mayor's designee of an application for a grant from the National Oceanic and Atmospheric Administration in the amount of \$1,967,093 toward the total project cost of \$2,049,103 for marine habitat creation in the coastal waters of Miami-Dade County; authorizes the Mayor or the Mayor's designee to receive and expend such grant funds, execute such contracts, agreements, memoranda of understanding, and amendments thereto which may be required by such grant for and on behalf of Miami-Dade County, after approval by the County Attorney's Office; authorizes the Mayor or the Mayor's designee to apply for, receive, and expend any additional grant funds which may become available to Miami-Dade County from the National Oceanic and Atmospheric Administration for marine habitat creation in waters of Miami-Dade County; and authorizes the Mayor or the Mayor's designee to exercise and

execute any amendments, modifications, renewal and extension provisions, cancellation clauses, and termination clauses in any such applications, contracts, agreements, and memoranda of understanding, after approval by the County Attorney's Office.

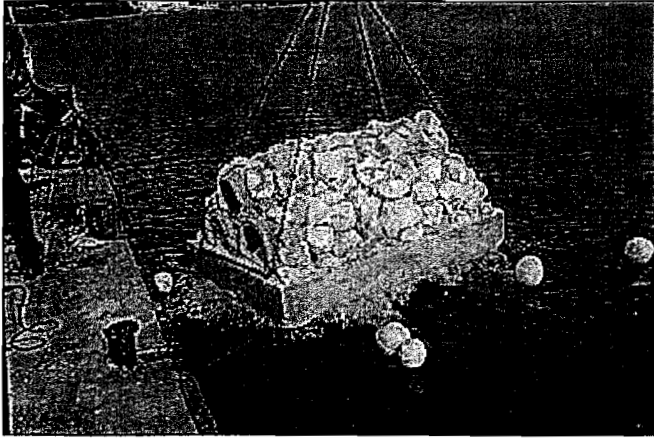

PROJECT SUMMARY

Application Organization: Miami-Dade County, Department of Environmental Resources Management (DERM)

Project Title: Miami-Dade County Coastal Marine Habitat Creation and Enhancement

Site Location: The artificial reef site located off the coast of Key Biscayne is within the “Key Biscayne Special Management Zone” and is located at 25° 41.821N; 80° 05.252W. The artificial reef site located off the shore of Miami-Beach is within the “Anchorage Reef Site” and is located at 25° 48.785N; 80° 05.358W. Both proposed sites are off Miami-Dade County shores.

Landowner: State of Florida

On-The-Ground Implementation Date: 90-days after execution of the funding agreement.

Numbers and types of jobs created or maintained, and anticipated duration for each: This project involves: construction of engineered reef modules (ERMs); land and sea transportation of the ERM's; deployment of ERMs on the ocean bottom; project management; and success evaluation. Jobs creation & support from this project are: Construction workers, Project Engineers, Heavy Equipment Operators, Tugboat Captain and Crew, Biologists, Inspectors Supervisors and Accountants. Although the hours for each category can't be absolutely calculated, it is anticipated that Construction workers, heavy equipment operators and inspectors will be required minimally for the 180 day length of the contracted portion of the project and the tug and barge captain and crew will have support for 30 days of that period. Job support will be provided to biologists and limited management staff for 60 days during the contract and an additional 45 days beyond, for success evaluation and assessment. Additionally, long term benefits will be realized by tourism related local small businesses in scuba diving charters, fishing charters, and local recreational fishing/boating industries.

Coastal and Marine Habitat Benefits from the Project: The proposed project will directly benefit the coastal and marine environment by creating and enhancing 2,420 m² (0.6 acres) of benthic marine habitat in the nearshore region off Miami-Dade County. These essential and diminishing habitats serve as breeding, feeding, and resting locations for a number of protected, managed and listed species. These habitats are: designated critical habitat for federally listed hard coral species (*Acropora cervicornis*, *Acropora palmata*); important feeding and resting areas for listed sea turtle species (*Caretta caretta*, *Chelonia mydas*, *Dermochelys coriacea*); and designated Essential Fish Habitat for numerous managed fish species.

Project Scope: Project objectives are to create 850 m² of hardbottom habitat, and enhance a surrounding 1,620 m² (=2,420 m² [0.6 acres] total) of benthic habitat creation and enhancement via the following activities: construction, land and sea transportation and deployment of

engineered reef modules (ERMs) on the ocean bottom; biological assessment and success evaluation and project oversight and management.

Project Outputs/Outcomes: Project outputs include: manufacturing and placing 164 prefabricated ERMs in two designated and permitted artificial reef sites: the “Key Biscayne Special Management Zone” and the “Anchorage Reef Site”; deploying an existing stock-pile of approximately 200 tons of carbonate based materials of opportunity in a location adjacent to one of the proposed reef sites; providing a physical footprint of 810 m² of created hardbottom benthic and fisheries habitat and enhancing an additional 1,620 m², through the synergistic effects of adjacent modules. Anticipated outcomes are: to enhance benthic and fisheries habitat; to provide suitable substrate for colonization and utilization by multiple listed species (*Acropora cervicornis*) and sea turtles (*Caretta caretta*, *Chelonia mydas*, *Dermochelys coriacea*), endolithic and epilithic algae, sponge, soft corals, and hard corals; to provide a spectrum of habitat (from open surfaces of varied texture and complexity, and multiple levels of confined/cryptic areas) to develop and support diverse and complex benthic and fish communities. Requested funds will provide immediate support to local construction and contracting businesses, enhance local tourism, and tourism related businesses. In addition requested personnel costs are intended to assist in retention of jobs required for implementation of the project through the FY 2009-2010.

Project Time Line: This project will be compliant with the ARRA ‘shovel-ready’ timeline. Construction will begin after an estimated 90-day contract bidding process. Construction initiation, deployment initiation, and deployment completion/certification will occur in an estimated 3.5 months (104 days). A biological evaluation of the ARMs will ensue for an additional 1 year period.

Permits and Approvals: Miami-Dade County has obtained all required Federal, State and local permits necessary for the proposed work (Attachment 1). Construction plans for manufacture and placement of the ARM’s are completed. State of Florida permits, as landowner, authorize work to be conducted on the proposed state-owned off shore sites.

Federal Funds Requested & Non-Federal Match Anticipated: \$1,967,093 is requested. \$82,010 is voluntarily provided as ‘matching’ funds.

Overall Project Cost: \$2,049,103
