

RECOMMENDATION

It is recommended that the Board approve the transfer of Passenger Motor Carrier (PMC) Certificate of Transportation No. 207 from Jorge Enrique Gamez Grosso d/b/a American Tours USA, Inc. to V.I.P. Shuttle Services, Corp.

SCOPE

This PMC Certificate of Transportation is countywide, allowing the certificate holder to operate in unincorporated and incorporated areas of Miami-Dade County.

FISCAL IMPACT/FUNDING SOURCE

There is no fiscal impact to the County.

TRACK RECORD/MONITOR

Applicant is an existing permit holder with one luxury sedan and one super stretch permit. The Consumer Services Department (CSD) will be responsible for monitoring this company. There has been some enforcement history. During the last five years, the applicant received 11 citations while operating a for-hire vehicle; however, eight of the citations were issued more than three years ago. Three were issued to chauffeurs, three for soliciting, three for failure to maintain an accurate trip sheet, one for failure to sign and accept a violation notice and another for abusive language. All citations have been satisfied.

BACKGROUND

On February 17, 1981, the Board of County Commissioners adopted Ordinance 81-17, subsequently amended by Ordinance 85-20 on April 16, 1985, which regulates the PMC industry in Miami-Dade County under Chapter 31 of the Code of Miami-Dade County.

Section 31-103 (m) of the Code provides the procedures to be followed by the County in processing transfer applications. No certificate may be sold, assigned or transferred to another until the proposed sale, assignment, or transfer has been approved by the Board. In considering the proposed transfer of ownership or control of the certificate, the Board shall determine whether or not said transfer is contrary to the public interest, upon evidence submitted at the May 12, 2009 Government Operations Committee meeting (Attachment A). The Board may approve or refuse to approve said transfer upon such terms and conditions or may reasonably alter, restrict or modify the terms and provisions of such transfer if in the public's interest.

American Tours USA, Inc. has filed an application to transfer PMC Certificate of Transportation No. 207 to V.I.P. Shuttle Services, Corp. Originally issued on April 16, 1996 via Resolution R-384-96 (Attachment B) to Casino Limousine, Inc., then transferred to American Tours USA, Inc. via Resolution R-385-07 (Attachment C), PMC No. 207 authorizes charter services. This class of service is defined as

transportation of a group of persons pursuant to a common purpose and traveling under a single contract involving the exclusive use of a motor vehicle.

The company is required to adhere to the terms of the resolution, which approved the initial certificate (R-384-96). V.I.P. Shuttle Services, Corp. located at 256 Pocatella Street, Miami, Florida 33166, seeks to continue providing this class of service by transporting resident and tourist groups to and from various locations throughout Miami-Dade County 24-hours a day, seven days a week. Transportation is required to be pre-arranged at least 24-hours prior to service, using chauffeur driven vehicles with a seating capacity of nine or more, but less than 28 passengers, excluding the driver. The proposed rates are listed on the rate schedule (Attachment D).

The management plan submitted by Mr. Munir Ghorab, President of V.I.P. Shuttle Services, Inc. includes maintenance, communication, and record keeping systems and meets the requirements of the Code. All required financial statements and credit references have been submitted and the proposed service standards adequately meet passenger transportation and comfort needs. A background investigation reveals no criminal conviction for the applicant or any corporate officers within five years of the date of the application. Although there has been some enforcement history within the last five years, approval is recommended to maintain the availability of licensed PMCs in Miami-Dade County thus providing competition and high service standards to the public. The Code does not exclude an applicant based on past violations as long as the violations have been satisfied.

As required by the Code, the applicant has provided disclosure of the terms and conditions regarding the transfer of the certificate. A sales agreement (Attachment E) between Mr. Jorge Enrique Gamez Grosso d/b/a American Tours USA, Inc. and Mr. Munir Ghorab, President of V.I.P. Shuttle Services, Corp. establishes the acquisition by V.I.P. Shuttle Services, Corp. of PMC Certificate of Transportation No. 207 for a total price of \$10,000.00.

RECOMMENDATION

It is recommended that the Board approve the application of Casino Limousine, Inc. for a Passenger Motor Carrier of Transportation to provide pre-arranged charter service.

BACKGROUND

On February 17, 1981, the Board of County Commissioners adopted Ordinance 81-17, subsequently amended by Ordinance 85-20 on April 16, 1985, which regulates the passenger motor carrier industry in Dade County under Chapter 31 of the Code of Metropolitan Dade County.

Section 31-103 of the Code provides the procedures to be followed by Metro Dade County in processing certificate applications. Based on those requirements, a public hearing has been scheduled before the Board of County Commissioners. At the conclusion of the public hearing the Board may issue or refuse to issue the certificate, or issue the certificate with such modifications or upon such terms and conditions as in its judgment the public interest may require. In reaching its determination, the Board shall consider the application, the County Manager's report and recommendation, all matters presented at the public hearing, and among others, the following criteria:

- (1) That the applicant is fit, willing and able in accordance with the requirements of this section, to provide the transportation to be authorized by this certificate and is able to comply with this article and regulations of the commission.
- (2) That the transportation to be provided under the requested certificate is consistent with the public interest.
- (3) That the proposed transportation service will improve the quality of transportation available to the public.

ANALYSIS

Casino Limousine, Inc., located at 7109 SW 127 Court, Miami, Florida 33183, seeks to obtain a Passenger Motor Carrier Certificate of Transportation to provide pre-arranged charter service to passengers throughout all of Dade County. This class of service is defined as the transportation of a group of persons pursuant to a common purpose and traveling under a single contract involving the exclusive use of a motor vehicle.

The company seeks to transport tourist and resident groups to various locations throughout Dade County. Transportation will be pre-arranged on a 24 hour minimum basis. These services will be provided 24 hours a day, seven days a week, using chauffeur driven vehicles with a seating capacity of nine or more, but less than 28 passengers, excluding the driver. The proposed rates are listed on the attached fare schedule.

The management plan submitted by Ms. Odalis Suarez, President of Casino Limousine, Inc., includes maintenance, communication, and record keeping systems and meets the requirements of the Code. All required financial statements and credit references have been submitted and the proposed service standards adequately meet passenger transportation and comfort needs. A background investigation reveals no criminal record for the applicant.

In accordance with Section 31-103(e) of the Code, a 20 day notice of application was provided to all affected municipalities within Dade County, all passenger motor carrier certificate holders and interested parties. No protests were filed.

ANALYSIS

Casino Limousine, Inc. has filed an application to transfer Passenger Motor Carrier (PMC) Certificate of Transportation No. 207 to Jorge Enrique Gamez Grosso d/b/a American Tours USA, Inc. The Code requires that such transfers be approved by the Board. PMC No. 207 was originally issued on April 16, 1996, to Casino Limousine, Inc. This certificate authorizes charter service – transportation of a group of persons pursuant to a common purpose and traveling under a single contract involving the exclusive use of a motor vehicle. Jorge Enrique Gamez Grosso d/b/a American Tours USA, Inc. located at 640 NW 36 Court, #C-3, Miami, Florida 33134, seeks to continue providing this class of service.



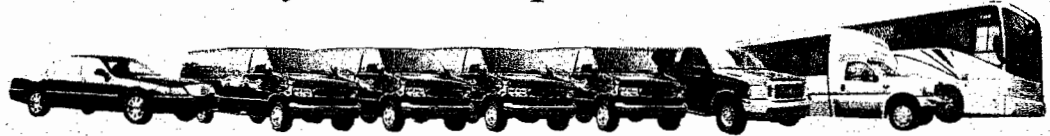
