Board of County Commissioners Zoning Hearing
March 20, 2008

The Board of County Commissioners met in regular session in the County Commission Chambers on the Second Floor of the Stephen P. Clark Government Center, 111 N.W. First Street, Miami, Florida at 9:30 a.m., March 20, 2008, there being present upon roll call the Honorable Chairman Bruno A. Barreiro and Commissioners Joe A. Martinez, Katy Sorenson, and Rebeca Sosa (Vice Chairwoman Barbara J. Jordan and Commissioners Sally A. Heyman and Dorrin D. Rolle were excused; Commissioner Javier D. Souto was absent on County business; and Commissioners Jose "Pepe" Diaz, Audrey M. Edmonson, Carlos A. Gimenez, Natacha Seijas, and Dennis C. Moss were absent); Assistant County Attorneys Joni Armstrong-Coffey and John McInnis; Interim Director for the Department of Planning and Zoning Subrata Basu; and Deputy Clerks Kay Sullivan and Scott Rappleye.

Chairman Barreiro noted he received memoranda apprising him that six commissioners would be absent, as well as one additional notification of absence; therefore, the March 20, 2008 Board of County Commissioners Zoning Hearing was cancelled due to a lack of quorum.


