Title: Schedule of Fees and Tolls for the Venetian Causeway

Ordered: 09/20/2007

Effective: 10/01/2007

AUTHORITY:

The Miami-Dade County Home Rule Amendment and Charter and Section 2-100 of the Code of Miami-Dade County.

SUPERSEDES:

This Implementing Order supersedes Administrative Order No. 4-56, ordered on September 22, 2005 and effective October 1, 2005.

POLICY:

This Implementing Order establishes the schedule of fees for cash toll passage, Card/Pass passage commuter Card/Pass passage, owner Card/Pass passage, Causeway Card/Pass deposit amounts, lost Causeway Card/Pass fees, Causeway Card/Pass account replenishment amounts, monthly statement fees and the Causeway Card/Pass transfer fee.

PROCEDURE:

The administration of this Implementing Order is designated to the Director, Miami-Dade County Public Works Department, who shall be responsible for the collection of tolls and fees, and the maintenance and operation of the Causeway pursuant to Section 2-100 relating to the power and duties of the Public Works Department. The Director shall periodically review all fees in terms of the Causeway's maintenance and operational costs, other financial obligations, and capital improvements needs, and recommend changes to the County Manager through this Implementing Order procedure.

FEE SCHEDULE:

The fee schedule adopted by this Implementing Order is attached hereto and made a part hereof, and is on file with the Clerk of the Board of County Commissioners. Fees charged by the Public Works Department shall be the same as those listed in the official fee schedule on file with the Clerk of the Board of County Commissioners.
