Background and Relevant Information

On April 24, 2007, through Resolution 462-07, amended by Resolution 1131-07, Miami-Dade County's Charter Review Task Force (Task Force) was created in order to review the County's Home Rule Charter and submit recommendations to the BCC setting forth any proposed amendments to the Charter.

According to the final report dated January 29, 2008, by the Task Force members, the BCC's compensation and term limits was deliberated, including a comparison of salaries and other benefits, length of term and term limitations, and limitations on outside employment for elected commissioners for Florida counties and selected national counties.

The Task Force considered and debated the following issues:

- A strong sentiment that the current structure under-compensates the members of the BCC for what is essentially a full-time job;
- A desire to eliminate the perception of conflicts of interest created by the need for outside employment;
- An awareness that previous attempts at the ballot to raise BCC salaries have failed;
- A belief that public support for a salary increase may require linkages to other issues, i.e. term limits and ethics regulations; and
- The advantages and disadvantages of term limits.

The Task Force concluded the following: (1) Commissioners should receive a population-based salary provided by Florida's statutory formula (approximately \$91,995); (2) Commissioners' terms in office should be limited to two (2), four-year terms; and (3) Commissioners should be prohibited from having outside employment. The restriction on outside employment is consistent with the desire to acknowledge the full-time demands of the Office of County Commissioners and to address public perception regarding the effect of outside employment on decisions made by the BCC, notwithstanding conflict of interest.

On July 18, 2008, the BCC held a special meeting to discuss twenty-two sponsored items pertaining to commissioner's salaries and service of County Commissioners. During the course of the special meeting, a number of Commissioners expressed their desire that the ballot question include no term limits and Commissioners has to devote full-time service to the office and hold no other employment. Commissioners also agreed to receive a salary provided by State statutory formula (approximately \$91, 995), adjusted annually by the County's population.

The election was held on November 4, 2008. (See election results below)

Summary

This resolution provides for the following: (1) declares surplus county-owned land located at 3090 N.W. 135 Street; (2) conveys the property at no cost to the North Miami Beach Medical Center (NMBMC) by a County Deed which will require the construction of a community clinic within 5 years; and provides restrictions for the use and re-conveyance of the property to ensure compliance with the intent of the Board of County Commissioners.

Relevant Information

North Miami Beach Medical Center is a 501(C) 3, Florida not-for-profit corporation. The NMBMC provides free medical services to low income families, adults and children, in North Miami Beach, Opa - Locka and the surrounding communities. The Center has a 32-foot-long 'Mercy Mobile' Medical Clinic for the purpose of going out into the inner city and other low income areas to serve the residents, many of whom do not have transportation to bring them to their facility.

They also provide on-location Medical Relief to victims of natural and man-made disasters.

Services provided at no cost to patients are:

- 1. Primary Care Internal Medicine and Geriatrics.
- 2. Pediatrics, including free immunizations and school physical exams.
- 3. Disaster Relief Medical Services.
- 4. Gynecology.
- 5. Preventive Medicine including nutrition and exercise teaching, and faith-based lifestyle adaptations.
- 6. Medical Education: Medical Students and Residents receive their Primary Care clinical training at North Miami Beach Medical Center.

Legislative History

On November 2, 2004, Miami-Dade County voters approved \$2.9 billion in Building Better Communities General Obligation Bond Program proceeds intended to finance countywide government improvement projects. Ballot Question No. 5, authorized up to \$171,281,000 in funding for projects "to construct and improve emergency healthcare facilities at Jackson Memorial Hospital (JMH) to promote accessibility to quality healthcare services, pursuant to Resolution 916-04, **adopted on July 20, 2004.**

During the course of the July 20, 2004 session, a number of commissioners expressed their desire that additional GOB funds be expended on community healthcare projects that would not be administered by JMH. Instead, it was intended that the monies would be directed to Federally Qualified Health Care Centers, and, in two instances, specific projects were identified as worthwhile candidates for the funding.¹

At the end of the session, in conjunction with several other oral amendments made with regard to other ballot questions, a vote was taken to increase funding for healthcare related projects-i.e. Ballot Question No. 5 by \$25 million. This additional funding, plus amounts for the anticipated costs to issue bonds, increased the total allotment of GOB funds for Ballot Question No. 5 from \$137 million to approximately \$171.2 million.

A new Project No. 305, named Primary Health Care Facilities was added to the GOB's recommended list of priorities. It reads: "increase the number of health care facilities in our community."

Although substantive language was changed in Ballot Questions 1 and 2, the only changes to the final Ballot Question No. 5 were the inclusion of the resolution number, its adoption date, and the increase funding from \$137 million to \$171.281 million.²

Questions

- 1. How will the NMBMC finance the construction phase?
- 2. How will the NMBMC sustain the future facility?
- 3. Has the NMBMC provided the County a business development plan?
- 4. Does the NMBMC qualify for existing or future GOB-BCC proceeds?

Summary

This resolution approves Amendment Number One (1) to the non-exclusive professional services agreement with AECOM Technical Services, Inc. (AECOM), formerly known as Earth Tech Consulting, Inc., is increasing the maximum **compensation** from \$4 million to \$6.5 million; and extends the contract term from six (6) years to ten years to provide additional engineering services for the design criteria to relocate a portion of the 54-inch Sanitary Sewage Force Main between Miami Beach and Fisher Island under Government Cut for the Miami-Dade Water and Sewer Department (WASD).

The additional compensation will be funded through WASD's Water Renewal and Replacement Fund, Wastewater Connection Charges and Future Revenue Bonds.

The current contract was executed in December 2008 for \$4,000,000 with a term of six (6) years.¹

Firm History Report

Below is a summary of AECOM's business history, change order history and other related findings:
