Subject: County Services Reserve Allocation Process

The Board of County Commissioners (BCC) has expressed the need to examine and improve the process by which in-kind reserve allocations are made and how the funds should be distributed, whether countywide or district specific, in addition to concerns with the loss of revenue to proprietary departments.

In response to these concerns the creation of the County Services Reserve was included in the FY 2006-07 Resource Allocation Plan. This reserve totals \$840,000 (\$60,000 for each elected office) to be allocated to provider County departments on behalf of the community-based organizations (CBOs) for those services previously requested and provided through the in-kind process for community events. This would allow all departments providing these contracted services to be compensated, including propriety departments.

To simplify the distribution of allocation(s) from the County Services Reserve, the Office of Strategic Business Management (OSBM) developed the attached application agreement form. Funding from the County Services Reserve would be processed in the same manner as the Discretionary Reserve allocations. An organization/agency requesting funding from the County Services Reserve will be required to submit a signed application agreement form to the elected official's office. This agreement also requires the requesting organization/agency to include estimates from the provider departments that will assist the elected official in determining what services to fund. Once the elected official has approved the amount to be allocated, the allocation is presented to the BCC for approval via motion or resolution. Upon receipt of the completed signed application agreement, OSBM will be responsible for transferring the dollars to the provider departments upon approval of the allocations by the Board of County Commissioners.
