# AUTHORITY:

The Miami-Dade County Home Rule Charter, including, among others, Section 1.01 and 2.02A, and Sections 5-5, 5-7, 5-8, 5-13, 5-14, 5-18, and 5-23 of the Code of Miami-Dade County.

#### SUPERSEDES:

This Implementing Order (IO) supersedes IO 4-51, ordered September 198, 20134, and effective October 1, 20134.

#### POLICY:

This Implementing Order establishes a schedule of fees for rabies vaccination, animal registration and license tags, adoption, impound/redemption charges, <u>veterinary services</u>, licenses, refundable deposits, <u>hearing fees, expert witness fees</u>, euthanasia, <u>and microchipping</u>, <u>and other services</u>.

#### FEE SCHEDULE:

The fee schedule adopted by this Implementing Order is attached hereto and made a part hereof. The official fee schedule is also filed with and subject to the approval of the Board of County Commissioners and on file with the Clerk thereof. Fees that are charged by the Animal Services Department shall be the same as those listed in the official fee schedule on file with the Clerk of the County Commission.

The Department Director or designee of the Animal Services Department shall have the authority to issue refunds of charges for adoption, medical, or impoundment services rendered under this Implementing Order, as may be required due to uncertainties or negative outcomes associated with those services. In addition, the Department Director or designee of the Animal Services Department shall have the authority to adjust or waive fees for services enumerated by this Implementing Order in the following circumstances: (1) as part of a promotional/marketing event; (2) for services provided to the homeless population; (3) for the purpose of negotiating for services rendered on behalf of large groups; or (4) on a case-by-case basis deemed to be in the best interest of the Department's goal of reducing the stray pet population, and, which would not adversely or materially impact the Department's annual budget.

The Department Director or designee of the Animal Services Department shall have the authority to make refunds of adoption as required due to uncertainties in such transactions or waive fees as part of a promotional/marketing event

Note 1: <u>Indigent\_Low income</u> owner is a Miami-Dade County resident, at least 18 years old, receiving public assistance (i.e. Food Stamps, Medicaid, Supplemental Security Income, Temporary Assistance for Needy Families (TANF), Jackson Memorial <u>Indigent\_Low Income</u> Medical Program). Pet owner shall provide letter (original copy) establishing federal/state benefits and period of eligibility to qualify for reduced fees as an <u>indigent\_low income</u> owner. <u>Discount applies only to annual license and vaccine.</u>

Note 2:\_-Requires evidence that vaccination is valid for 3-years. Three (3) year license fee shall not be pro-rated or refunded.

Note 3: <u>-In lieu of paying impoundment and animal care fees, o</u>Qwners redeeming impounded animals may choose "Return to Owner Services", <u>-which may include all or -only some of the services typically offered as part of an adoption package, depending on the needs of the particular animal.</u>

" (see "Adoption" fees), which includes microchip, vaccines, license, and spay/neuter service, in lieu of paying impoundment and animal care fees.

Note 4: Hobby Breeders who were validly registered prior to February 21, 2008, shall be required to annually renew their hobby breeder licenses, but will be exempted from paying any additional fees for their hobby breeder licenses. However, failure to annually renew their license will result in forfeiture of fee exemption.

Note 5: Refundable deposits shall be maintained in the Animal Services Trust Fund as established by Resolution No. R-575-07, as may be amended from time to time.

Note 11: Refundable deposits shall be maintained in the Animal Services Trust Fund as established by Resolution No. R-575-07, as may be amended from time to time.
