



RESOLUTION APPROVING THE ALLOCATION OF \$3 MILLION FROM BUILDING BETTER COMMUNITIES GENERAL OBLIGATION BOND PROGRAM PROJECT NUMBER 219 – “ACQUIRE OR CONSTRUCT MULTI-PURPOSE FACILITIES” TO FUND DEVELOPMENT OF MULTI-PURPOSE FACILITY OWNED BY LITTLE HAVANA ACTIVITIES & NUTRITION CENTERS OF DADE COUNTY, INC. WHICH FACILITY SHALL INCLUDE INTERGENERATIONAL CHILD CARE CENTER, ADULT DAY CARE CENTER AND COMMUNITY AND ACTIVITY ROOMS

WHEREAS, Appendix A to Resolution No. R-917-04 lists projects eligible for funding from the Building Better Communities General Obligation Bond Program (the “BBC Program”) by project number, municipal project location, BCC district, project name, project description, street address and allocation; and

WHEREAS, BBC Program Project No. 219 – “Acquire or Construct Multipurpose Facilities” includes an allocation of \$3 million to fund the acquisition or construction of multipurpose facilities for various uses to be located in BCC district five; and

WHEREAS, the Little Havana Activities & Nutrition Centers of Dade County, Inc. (“LHANC”) owns property located at 725 SW 9th Street, 728 SW 8th Street, 740 SW 8th Street Miami, FL 33130, which the LHANC wishes to use to develop a multipurpose facility that would be owned by LHANC and which shall include an intergenerational child care center, an adult day care center and community and activity rooms; and

WHEREAS, the intergenerational child care center will serve an estimated 20 children from low and moderate income families who live in the Little Havana area, and the staff will be recruited from the Little Havana area as well; and

WHEREAS, the adult day care center will serve approximately 78 frail, low and moderate income seniors who require supervision as a result of some disabling condition, including but not limited to Alzheimer's related dementia, and who may live in the Little Havana area; and

WHEREAS, the community and activity rooms will be used to provide recreation, education, and entertainment activities to seniors who are independent and active living in the Little Havana area as an expansion of the current senior center activities provided at the Rafael Villaverde Senior Center located adjacent to the proposed project; and

WHEREAS, the LHANC's multipurpose facility will be located on the first three levels of a building that will also include 94 units of low-income housing consisting of 1 and 2 bedroom units that will be funded from tax credits and other non-related funding sources; and

WHEREAS, this Board desires to allocate \$3 million from BBC Program Project No. 219 – "Acquire or Construct Multipurpose Facilities" to fund the LHANC multipurpose facility which shall include an intergenerational child care center, an adult day care center and community and activity rooms,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that:

Section 1. This Board hereby finds that the project described above is a "multipurpose facility" eligible for funding from BBC Program Project No. 219.

Section 2. This Board hereby allocates \$3 million from BBC Program Project No. 219 – "Acquire or Construct Multipurpose Facilities" to fund a multipurpose facility to be owned by the LHANC which shall include an intergenerational child care center, an adult day care center and community and activity rooms.

The Prime Sponsor of the foregoing resolution is Commissioner Bruno A. Barreiro. It was offered by Commissioner _____, who moved its adoption. The motion was seconded by Commissioner _____ and upon being put to a vote, the vote was as follows:
