ITEM # 2 LICENSING REQUIREMENTS FOR CERTIFICATION OF CODE PERSONNEL

For the record, there was a large audience present for this agenda item which consisted of Building Officials and Inspectors. This item was scheduled at the request of Arnold Velasquez, Board of Rules and Appeals and committee member. However, Mr. Velasquez was not present and there was an attempt to defer this matter. But, due to the overwhelming attendance, discussion took place. Mr. Francisco Quintana, Secretary to the Board of Rules and Appeals and Department Director, informed the committee and all interested parties present that the issue was does one need to maintain their license in order to remain certified as code personnel.

Mr. Salvador clarified that to mean that the license, although on "inactive status" by the unincorporated county policy, has to be valid not delinquent. In other words not expired. Those municipalities that allow Code Personnel to keep their contracting license active the Board decides on a case by case basis whether they will be allowed to do contracting work within that municipality if they are performing the duties of Code Personnel.

Roy Van Wyk, Chief of Electrical Division of the Building Department, addressed the committee and stated that the new Florida Building Code on the requirements for certification of Code Personnel, as it is written by the words "having held", he interprets it to mean that only at the initial time of application for certification is the license required to be valid and current with renewal fees and continuing education requirements met. Additionally, that it was the intent of the generating ordinance # 01-119 to give the license holder the option. Mr. Van Wyk felt that after that submission and approval for certification as Code Personnel the upkeep of license is not necessary saving the license holder renewal fees for a license that they are not actively using. Further, that the renewal of license serves no material effect to do their job purpose other than taking the money.

Pete Quintela, Code Compliance Specialist, added that this issue originating from a job advertisement in the Miami Herald. Mr. Velasquez questioned as to whether there is a reason to mandate paying fees for inactive license. The problem with the wording in the new code being that the words "valid license" were removed.

Jorge Gamoneda, Code Compliance Specialist, stated that the words "having <u>held</u>" in the new code refers to the <u>past</u> five years but does not necessarily clearly eliminates the future upkeep of license, and, therefore, it can be interpreted both ways.

After much discussion and deliberation, wherein this committee discussion went into and overlapped with the Board of Rules and Appeals meeting, a motion was made by Mr. Salvador and seconded by Mr. Kurzman to continue to uphold the requirement of maintaining a valid license. The motion carried with Mr. Weitz opposing.
