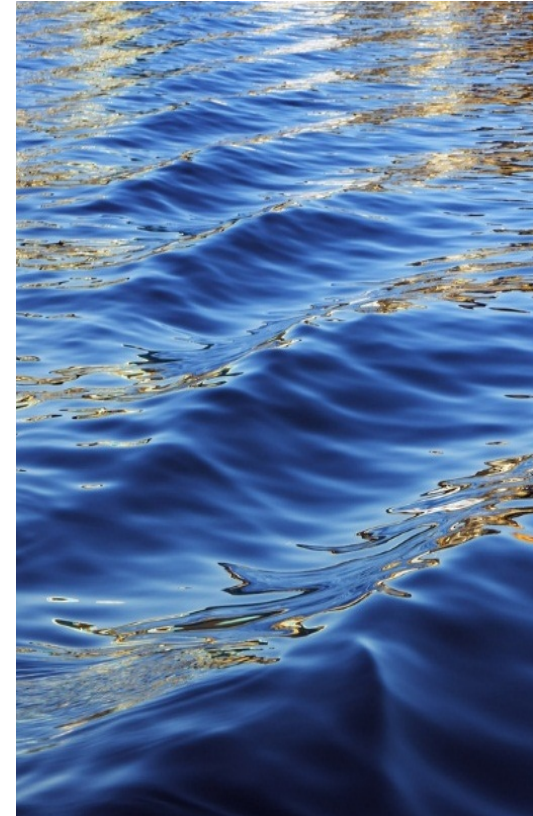


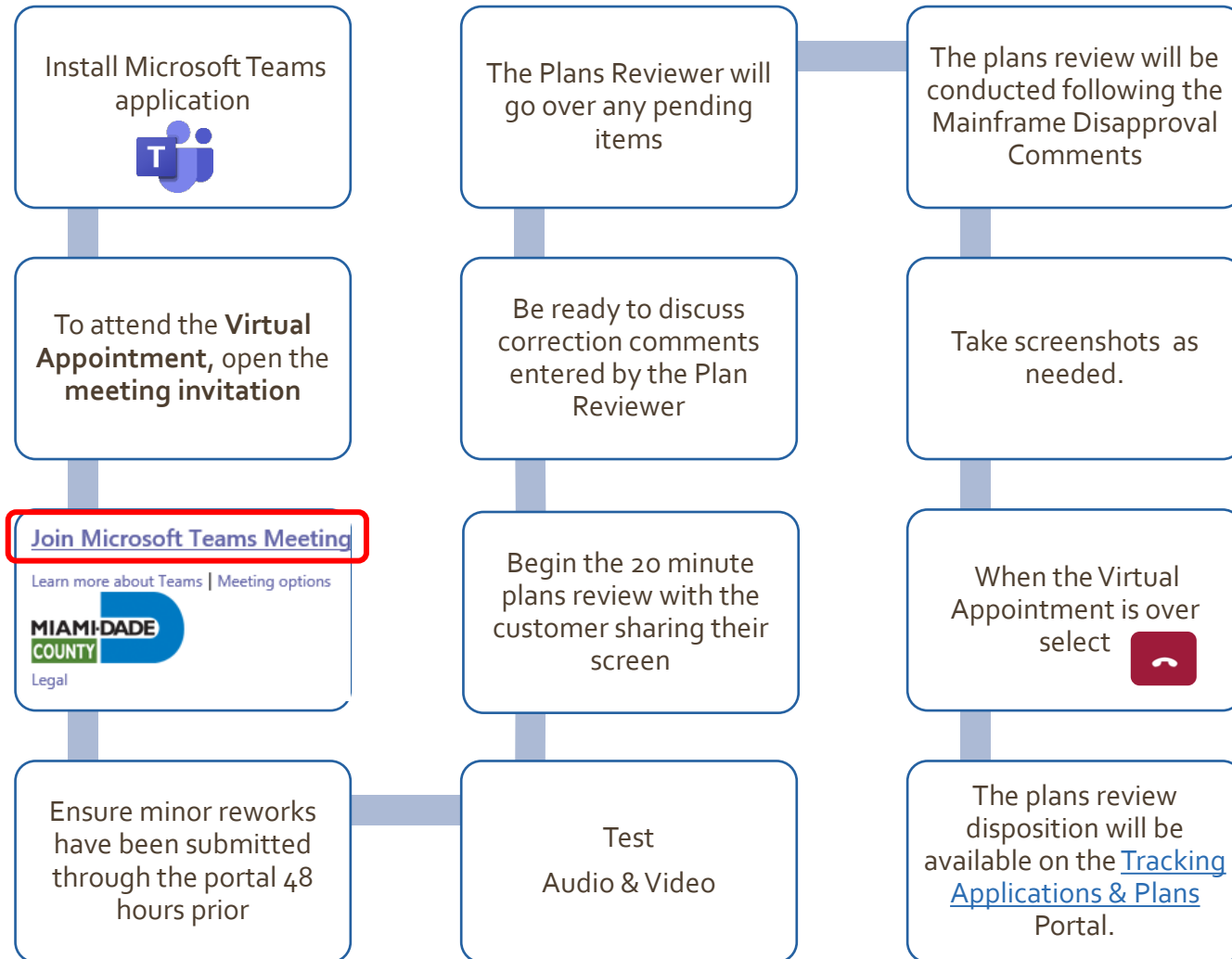

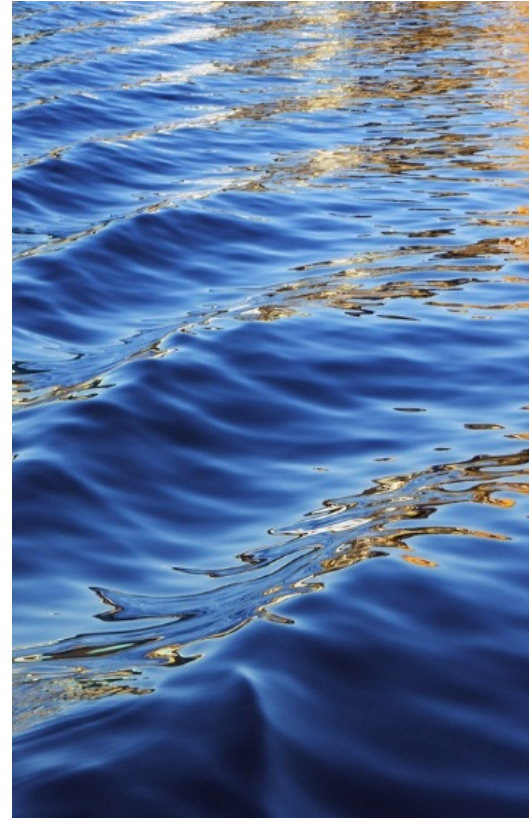
Procedures for Virtual Meetings

- The appointment will be performed using Microsoft Teams, please make sure you have the Microsoft Teams App downloaded on your device and familiarize yourself with these Guidelines for using Microsoft Teams.
- **Join the meeting 5 minutes prior to the scheduled time.**
- At the time of the appointment please ensure you have the following:
 - A broadband internet connection, as well as, audio and microphone capabilities.
 - Familiarize yourself with sharing your screen on Microsoft Teams
 - Be ready to accept a video call.
 - Be prepared to discuss the pending correction comments with the Plans Examiner.
 - Make sure any minor rework being discussed have been uploaded via the submission portal and available before the appointment.

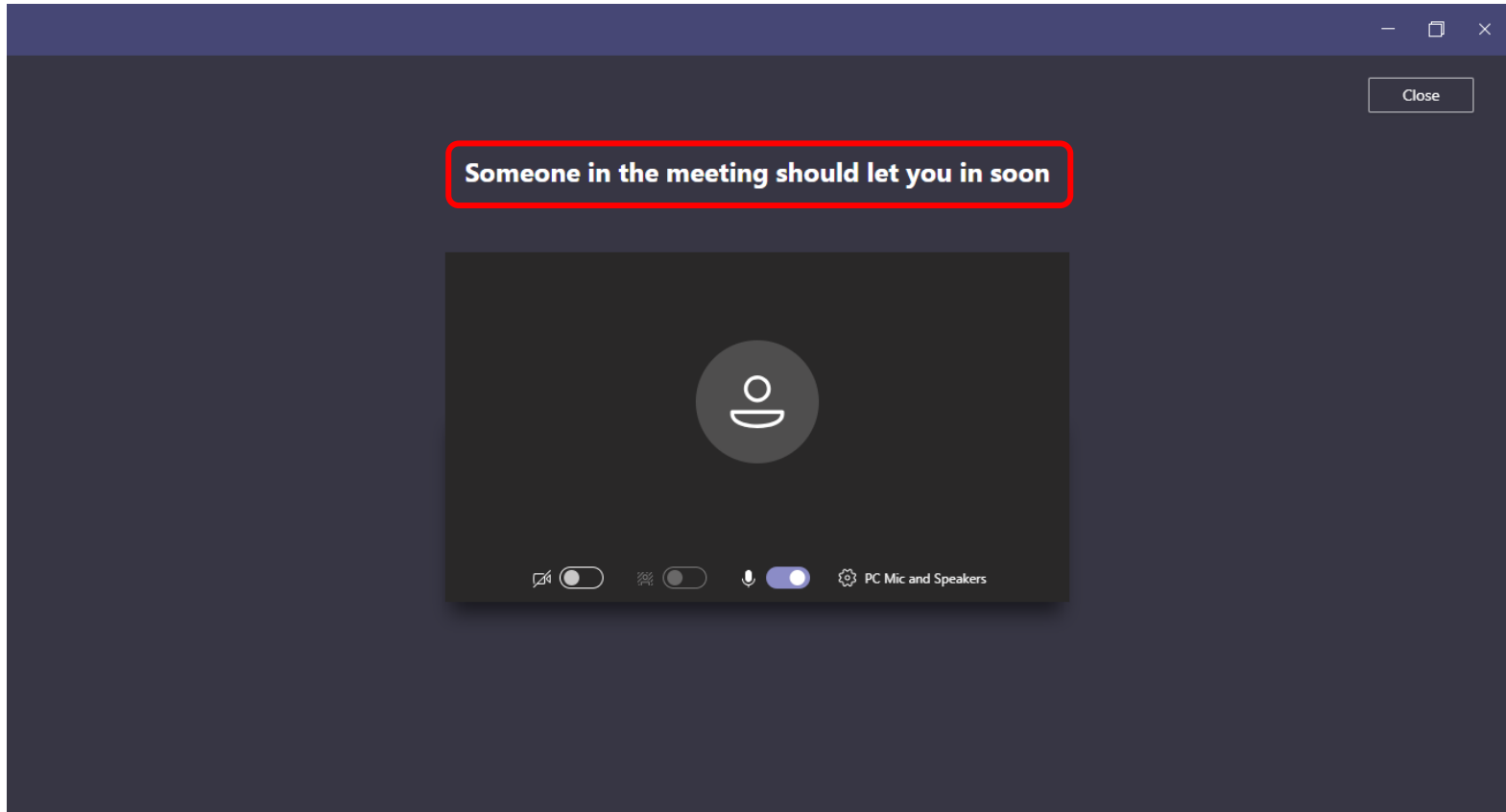

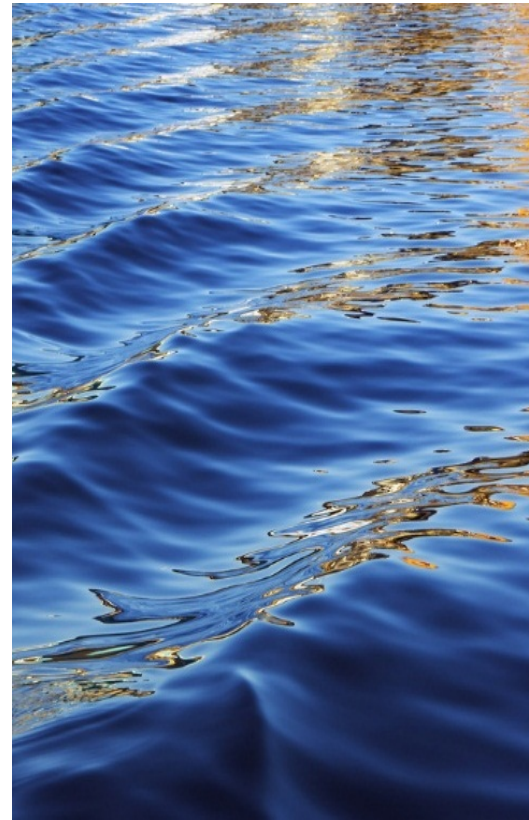

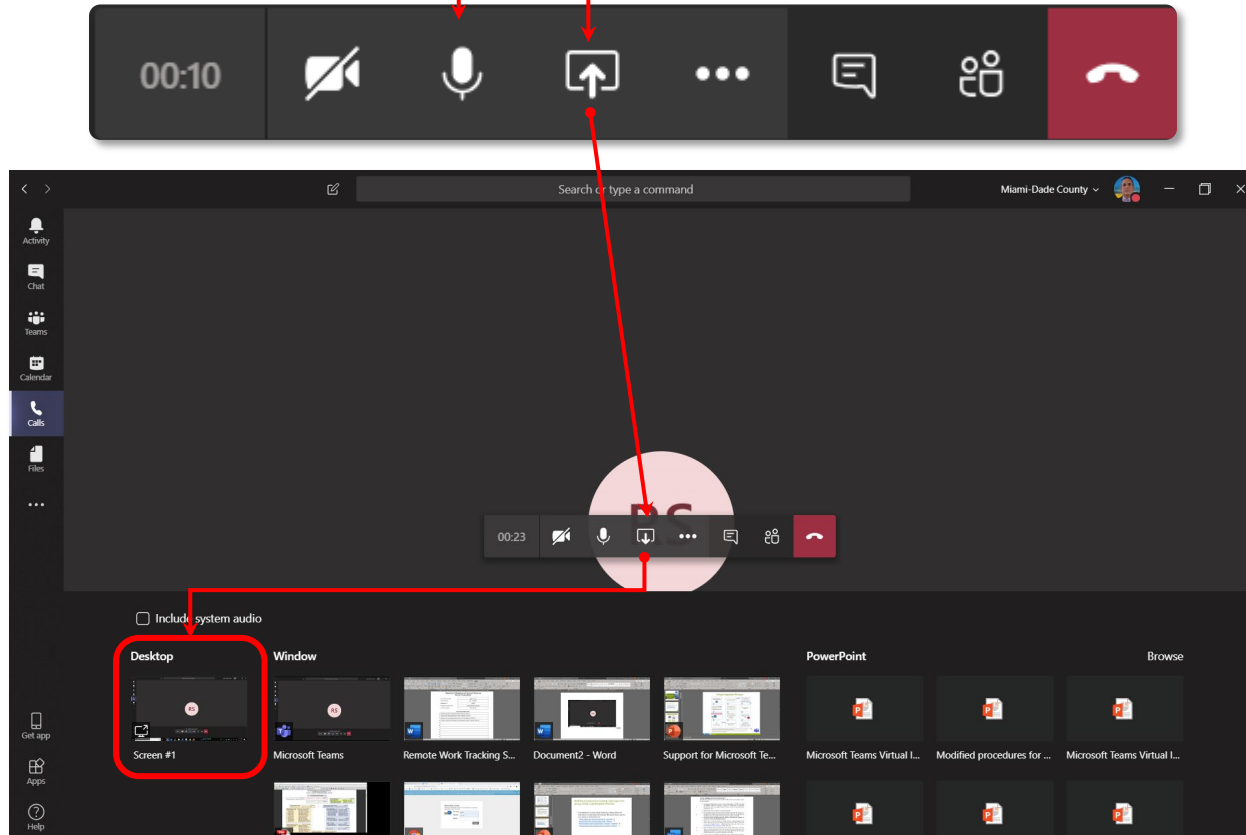
