**NOTICE OF ACCEPTANCE: SPECIFIC CONDITIONS**

**1. SCOPE**

This approves a 0.042" (min.) Structural Galvanized Steel Roof Panel, as described in Section 2 of this Notice of Acceptance, designed to comply with the South Florida Building Code, 1994 Edition for Miami-Dade County, for the locations where the load requirements, as determined by SFBC Chapter 23, do not exceed the design load values indicated in the approved drawings.

**2. PRODUCT DESCRIPTION**

This 0.042" (min.) Structural Galvanized Steel Roof Panel and its components shall be constructed in strict compliance with the following documents: Drawing No. D-1, D-2, D-3, and D-4, titled "SRS3-1.0 ~ 20 Gage Roof Panels", prepared by Chunbo Shim, P.E., dated December 21, 2001, sheets D-1 & D-2, dated October, 12, 2001, sheets D-3 & D-4, signed and sealed by Chunbo Shim, P.E., bearing the Miami-Dade County Product Control approval stamp with the Notice of Acceptance number and approval date by the Miami-Dade County Product Control Division. These documents shall hereinafter be referred to as the approved drawings.

**3. LIMITATIONS**

All permanent set components must be protected against corrosion, contamination and damage at all times.

**4. INSTALLATION**

This 0.042" (min.) Structural Galvanized Steel Roof Panel and its components shall be installed in strict compliance with the approved drawings.

**5. LABELING**

Each panel shall bear a permanent label with the manufacturer's name or logo, city, state and the following statement: "Miami-Dade County Product Control Approved".







**NOTICE OF ACCEPTANCE: STANDARD CONDITIONS**



3. Renewals of Acceptance will not be considered if:
  - a. There has been a change in the South Florida Building Code affecting the evaluation of this product and the product is not in compliance with the code changes.
  - b. The product is no longer the same product (identical) as the one originally approved.
  - c. If the Acceptance holder has not complied with all the requirements of this acceptance, including the correct installation of the product.
  - d. The engineer, who originally prepared, signed and sealed the required documentation initially submitted, is no longer practicing the engineering profession.
4. Any revision or change in the materials, use, and/or manufacture of the product or process shall automatically be cause for termination of this Acceptance, unless prior written approval has been requested (through the filing of a revision application with appropriate fee) and granted by this office.
5. Any of the following shall also be grounds for removal of this Acceptance:
  - a. Unsatisfactory performance of this product or process.
  - b. Misuse of this Acceptance as an endorsement of any product, for sales, advertising or any other purposes.




TOP VIEW




FRONT VIEW




EAVE DETAIL




VALLEY DETAIL
