For the locations where the pressure requirements, do not exceed the design pressure values obtain by calculations in compliance with RAS 127 using the values listed in section 4 herein. The attachment calculations shall be done as a moment based system.

## 3. LIMITATIONS

- **3.1** Fire classification is not part of this acceptance.
- **3.2** For mortar or adhesive set tile applications, a static field uplift test shall be performed in accordance with RAS 106.
- **3.3** Applicant shall retain the services of a Miami-Dade County Certified Laboratory to perform quarterly test in accordance with PA 112, appendix 'A'. Such testing shall be submitted to the Building Code Compliance Office for review.
- **3.4** Minimum underlayment shall be in compliance with the applicable Roofing Applications Standards listed section 4.1 herein.
- **3.5** 30/90 hot mopped underlayment applications may be installed perpendicular to the roof slope unless stated otherwise by the underlayment material manufacturers published literature.
- **3.6** This acceptance is for wood deck applications. Minimum deck requirements shall be in compliance with applicable building code.

#### 4. INSTALLATION

- 4.1 Hanson Rustic Shake/ Rustic Slate and 9" Flat Roof Tile and its components shall be installed in strict compliance with Roofing Application Standard RAS 118, RAS 119, and RAS 120.

  - **6.1.2** Any other documents required by the Building Official or applicable building code in order to properly evaluate the installation of this system.




