APPROVED SYSTEMS:

Deck Type: Wood, Non-insulated

Deck Description: $19/32$ " or greater plywood or wood plank.

Slope Range: 3:12 or greater

Maximum Uplift

Pressure: The maximum allowable uplift pressure shall be **-110 psf**.

Deck Attachment: In accordance with applicable Building Code, but in no case shall it be less than #8 x 2" wood screws spaced 6" o.c. In reroofing, where the deck is less than $19/32$ " thick (Minimum $15/32$ ") The above attachment method must be in addition to existing attachment.

Underlayment: Minimum underlayment shall be an ASTM D 226 Type II installed with a minimum 4" side-lap and 6" end-laps. Underlayment shall be fastened with corrosion resistant tin-caps and 12 gauge 1 1/4" annular ring-shank nails, spaced 6" o.c. at all laps and two staggered rows 12" o.c. in the field of the roll. Or any approved underlayment with a current NOA.

Valleys: Valley construction shall be in compliance with Roofing Application Standard RAS 133 and with manufacturers current published installation instructions.

Fire Barrier Board: Any approved Fire Barrier having a current NOA. Or for class A or B fire rating, install minimum 1/4" thick Georgia Pacific "Dens Deck" (with current NOA) or minimum 4mm thick of Tritex, RockRoof (with current NOA) or $5/8$ " water resistant type X gypsum sheathing with treated core and facer.

Starter: Install required starter over the eave and rake 1". The starter course is set in an 8" wide 1/8" thick bed of asphalt cement and fastened to the deck with 11ga 1-1/2" x 3/8" galvanized annular ring shank nails placed 2" from the eave edge and 1" from each side. The first course is to be adhered to the starter course with a 1/2" continuous bead of Geocel 2300 in addition to the nailing pattern described below. Nails shall be of sufficient length to penetrate sheathing $3/16$ ".

Application: Eco-Shake shingles shall have a maximum 10" exposure (see Detail 'B'). Eko-Shake shall be fastened with a minimum of three corrosion resistant ring shank nails at the locations shown in Detail 'A'. Nails shall be of sufficient length to penetrate through the sheathing a minimum of $3/16$ ".




GENERAL LIMITATIONS:

1. Fire classification is not part of this acceptance; refer to a current Approved Roofing Materials Directory for fire ratings of this product.
2. The maximum designed pressure limitation listed shall be applicable to all roof pressure zones (i.e. field, perimeters, and corners). Neither rational analysis, nor extrapolation shall be permitted for enhanced fastening at enhanced pressure zones (i.e. perimeters, extended corners and corners).
3. All panels and clips shall be permanently labeled with the manufacturer's name or logo, city, state and the following statement: "Miami Dade County Product Control Approved".
4. All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule 9B-72 of the Florida Administrative Code.


DETAIL 'A'
