APPROVED ASSEMBLY:

SYSTEM A-1: Stand 'N' Seam Aluminum Roof Panel
Deck Type: Wood, Non-insulated
Deck Description: New Construction ¹⁹/₃₂" or greater plywood or wood plank.
Slope Range: 2":12" or greater
Maximum Uplift Pressure: See Table A below. (See General Limitation #1)

Deck Attachment: Deck shall be attached in accordance with applicable Building Code, but in no case shall it be less than 8d ring shank nails spaced 6" o.c. In reroofing, where the deck is less than ¹⁹/₃₂" thick (Minimum ¹⁵/₃₂"") the above attachment method must be in addition to existing attachment.

Underlayment: Minimum underlayment shall be an ASTM D 226 Type II installed with a minimum 4" side-lap and 6" end-laps. Underlayment shall be fastened with corrosion resistant tin-caps and 12 gauge 1 ¼" annular ring-shank nails, spaced 6" o.c. at all laps and two staggered rows 12" o.c. in the field of the roll. Or, any approved underlayment having a current NOA.

Fire Barrier Board: Any approved fire barrier having a current NOA. Or for class A or B fire rating, install minimum ¼" thick Georgia Pacific "Dens Deck" (with current NOA) or minimum 4mm thick of Tritex, RockRoof (with current NOA) or ⁵/₈" water resistant type X gypsum sheathing with treated core and facer.

Valleys: Valley construction shall be in compliance with Roofing Application Standard RAS 133 and with Fabral, Inc. current published installation instructions.

Metal Panels and Accessories: Install the "Stand 'N' Seam Aluminum Roof Panels" and accessories in compliance with Fabral, Inc.'s current, published installation instructions and details. Flashing, penetrations, valley construction and other details shall be constructed in compliance with the minimum requirements provided in Roofing Application Standards RAS 133.

Panels shall be installed with approved clips (3" long x ¾" wide x ¾" tall), attached to substrate with two corrosion resistant #10 screws of sufficient length to penetrate through the sheathing a minimum of 3/16", located 3" from each panel end and at a maximum spacing listed in **Table A** below.

Panels shall be seamed together, forming a 180° seam at the overlap. See Detail Drawings herein.




SYSTEM LIMITATIONS

1. Neither rational analysis, nor extrapolation shall be permitted for the maximum design pressures listed in the "Perimeter and Corner" roof areas as noted in the Approved Assembly herein.
2. Panel shall be roll formed in continuous lengths from eave to ridge. Maximum lengths shall be described in the Roofing Application Standard RAS 133.
3. All panels shall be permanently labeled with the manufacturer's name or logo, city, state and the following statement: "Miami Dade County Product Control Approved". All clips shall be permanently labeled with the manufacturer's name and/or logo, and/or model.




STAND 'N' SEAM ALUMINUM PANEL



Panel Clip


BEFORE SEAMING




Panel Clip
