## APPROVED APPLICATIONS:

**Trade Name:** ProfileVent

**System Type A:** Mechanical attachment of static ridge vent over metal roof panels and under Metal roof ridge cap.

- Installation:**
1. Allow a 3" opening centered in the deck at the ridge for ventilation. The slot shall terminate approximately 12" from the rake edges.
  2. Rollout ProfileVent along ridge about ½" to 1" up-slope from edge of metal roof ridge cap from gable to gable.
  3. ProfileVent can be cut with scissors or utility knife.
  4. When splicing ProfileVent make the splice at the center top of the high rib and use caulk or sealant along the splice
  5. Fasten the metal roof ridge cap according to the metal roof manufacturer's instructions; but in no case shall it be less than a #14 x 2" corrosion resistant hex head screw with a weather seal washer fastened at a maximum spacing of 9" o.c. along both sides of metal roof ridge cap and through each rib of the metal roof panel.

**Minimum Slope:** 3:12

## SYSTEM LIMITATIONS:



1. Refer to applicable Building code for required ventilation.
2. Ridge vent ventilators shall not be installed on roof mean heights greater than 33 ft.
3. All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule 9B-72 of the Florida Administrative Code.
4. Ridge Vent shall comply with 1517.6 of the Florida Building Code (FBC).






