- 4.2 This product is to be used as an alternate to the wood nailer set in an approved adhesive specified in RAS-118 section 3.11 Detail #2, RAS-119 section 3.12 Detail #2, and RAS-120 section 3.10 Detail #2.
- 4.3 All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule 9B-72 of the Florida Administrative Code.

**5. INSTALLATION**

- 5.1 This product is to be installed as specified in RAS-118 section 3.11 Detail #2, RAS-119 section 3.12 Detail #2, and RAS-120 section 3.10 Detail #2 with a minimum continuous strip of PolyPro AH-160 adhesive at a rate of 32 grams/ft. creating a continuous 4” wide contact area against the hip or ridge section of the prepared roof deck. **See Detail A.**
- 5.2 Concrete or clay ridge tile shall be installed as specified in RAS-118 section 3.11 Detail #2, RAS-119 section 3.12 Detail #2, and RAS-120 section 3.10 Detail #2 with a minimum continuous strip of PolyPro AH-160 adhesive at a rate of 32 grams/ft. on top of the “Top Notch” Ridge Tile member creating a continuous 4” wide contact area to the cap tile. **See Detail A.**

**6. LABELING**

- 6.1 “Top Notch” Ridge Tile System shall be labeled with the Miami-Dade Product Control Approved Seal as seen below or the wording “Miami-Dade County Product Control Approved”.



**7. BUILDING PERMIT REQUIREMENTS**

- 7.1 Application for building permit shall be accompanied by copies of the following:
  - 7.1.1 This Notice of Acceptance.
  - 7.1.2 Any other documents required by the Building Official or the applicable code in order to properly evaluate the installation of this component.




