Substrates: Galvanized Metal Roofs, EPDM membranes, PVC membranes, Granular Surfaced SBS membranes, BUR membranes, Spray Polyurethane Roofs and Concrete.

Application Rate: Apply a Base Coat at a minimum rate of 50-125 ft²/1 gal. with a minimum thickness of 10 wet mils.
Apply two Finish Coats at a minimum rate of 50-125 ft²/1 gal. with a minimum thickness of 10 wet mils.

Specifications: ASTM D 6083

Description: An acrylic white elastomeric coating membrane applied to; Galvanized Metal Roofs, EPDM membranes, PVC membranes, Granular Surfaced SBS membranes, BUR membranes, Spray Polyurethane Roofs and Concrete.

Container Size: 1, 5 gallons. Note all cautions on container label.

Systems Approvals: Methods of application and quantities shall comply with the specific Roof Assembly System’s Product Control Notice of Acceptance where it exceeds standards of this NOA.



LIMITATIONS:

1. Fire classification is not part of this acceptance; refer to a current Approved Roofing Materials Directory for fire rating of this product.
2. 280 Roof Mastic Elastomeric Coating shall not be applied in inclement weather conditions.
3. The products listed herein are components of roof assemblies and are approved for use with roof assemblies that list the products listed herein as part of their roof assemblies Notice of Acceptance.
4. All products listed herein shall have an unannounced follow-up quality control program from an approved listing agency. Follow up test results shall be made available to BCCO upon request.
5. Change in materials, use, or manufacture of any products listed herein shall be cause for termination of this Notice of Acceptance.
6. 280 Roof Mastic Elastomeric Coating shall be applied in accordance with manufacturer's published application instructions.
7. All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule 9B-72 of the Florida Administrative Code.
8. All approved products listed herein shall be labeled in compliance with TAS 121 and shall bear the imprint or identifiable marking of the manufacturer's name or logo and following statement: "Miami-Dade County Product Control Approved" or the Miami-Dade County Product Control Seal as shown below.
