APPROVED ASSEMBLY:

SYSTEM: Decra Shingle
Deck Type: Wood, Non-insulated
Maximum Uplift Pressure: The maximum allowable uplift pressure shall be **-77.5 psf.**
(See General Limitations #1).

Deck Attachment: In accordance with applicable Building Code, but in no case shall it be less than #8 x 2" wood screws spaced 6" o.c. In reroofing, where the deck is less than 19/32" thick (Minimum 15/32") the above attachment method must be in addition to existing attachment.

Fire Barrier: Any approved fire barrier having a current NOA. Or for a class A or B fire rating, install minimum 1/4" thick Georgia Pacific "Dens Deck" (with current NOA) or minimum 4mm thick of Tritex, RockRoof (with current NOA) or 5/8" water resistant type X gypsum sheathing with treated core and facer.

Underlayment: Minimum underlayment shall be an ASTM D 226 Type II installed with a minimum 4" side-lap and 6" end-laps. Underlayment shall be fastened with corrosion resistant tin-caps and 12 gauge 1 1/4" annular ring-shank nails, spaced 6" o.c. at all laps and two staggered rows 12" o.c. in the field of the roll. Or, any approved underlayment having a current NOA.

Valleys: Valley construction shall be in compliance with the minimum requirements provided in Roofing Application Standard RAS 133.

Metal Panels and Accessories: Install the " Decra Shingle " and accessories in compliance with Decra Roofing Systems Inc.' current, published installation instructions and details. Flashings, penetrations, valley construction and other details shall be constructed in compliance with the minimum requirements provided in Roofing Application Standard RAS 133.

Panels shall be fastened with corrosion resistant #12 pan head screw with slotted indented hex-washer of sufficient length (but not less than 1") to penetrate through the sheathing a minimum of 3/16", at a spacing not to exceed 6" o.c. for a minimum of eight screws for each full panel length. (See detail drawings herein) Fastening shall be with the use of the Decra Shingle 24 ga. Stiffing channel. Shingle panels shall be staggered from right to left, and shall be positioned so that they cover the joints in the preceding course and adjacent courses shall be offset a minimum of 3 in. In any three adjacent courses no two joints should be directly aligned. Panel racking shall not be allowed.



GENERAL LIMITATIONS


1. The maximum designed pressure listed herein shall be applicable to all roof pressure zones (i.e. field, perimeters, and corners). Neither rational analysis, nor extrapolation shall be permitted for enhanced fastening at enhanced pressure zones (i.e. perimeters, extended corners and corners).
2. All panels shall be permanently labeled with the manufacturer's name and/or logo, and the following statement: "Miami-Dade County Product Control Approved" **or** with the Miami-Dade County Product Control Seal as seen below. All clips shall be permanently labeled with the manufacturer's name and/or logo, and/or model.




3. Any modifications to this Notice of Acceptance shall void such approval.


DECRA SHINGLE




DECRA SHINGLE SIDE PROFILE
