INSTALLATION:

1. Typar™ Surround SR Underlayment shall be installed in strict compliance with applicable Building Code.
2. Typar™ Surround SR Underlayment shall be installed with a minimum 4-inch head lap and 6" side laps in a single layer fashion.
3. Typar™ Surround SR Underlayment is a component used in roof assemblies. Roof assemblies are approved under specific assembly Notice of Acceptance.
4. Typar™ Surround SR Underlayment may be used with any approved roof covering Notice of Acceptance listing Typar™ Surround SR Underlayment as a component part of an assembly in the Notice of Acceptance. If Typar™ Surround SR Underlayment is not listed, a request may be made to the Authority Having Jurisdiction (AHJ) or the Miami-Dade County Product Control Department for approval provided that appropriate documentation is provided to detail compatibility of the products, wind uplift resistance, and fire testing results.
5. Typar™ Surround SR Underlayment is a non-asphaltic underlayment that may be used as a fire barrier for prepared roof assemblies. For fire classification of specific roof assemblies using Typar™ Surround SR Underlayment refer to a current Approved Roofing Materials Directory for fire ratings of this product.

LIMITATIONS:

1. Fire classification is not part of this acceptance, refer to a current Approved Roofing Materials Directory for fire ratings of this product
2. This acceptance is for prepared roofing applications. Minimum deck requirements shall be in compliance with applicable building code.

LABELING:
