LIMITATIONS:

1. Fire classification is not part of this acceptance.
2. HANDI-STICK can be used with flat, low, medium and high tile profiles.
3. Minimum underlayment shall be in compliance with the Roofing Application Standard RAS 120.
4. Roof Tile manufactures acquiring acceptance for the use of HANDI-STICK roof tile adhesive with their tile assemblies shall test in accordance with TAS 101 with section 10.4 as modified herein.

INSTALLATION:

1. HANDI-STICK may be used with any roof tile assembly having a current NOA that lists moment resistance values with the use of HANDI-STICK
2. HANDI-STICK shall be applied in compliance with the Component Application section and the corresponding Placement Details noted herein. The roof tile assembly's adhesive attachment with the use of HANDI-STICK shall provide sufficient attachment resistance, expressed as a moment based system, to meet or exceed the moment resistance determined in compliance with Roofing Application Standards RAS 127. The adhesive attachment data is noted in the roof tile assembly NOA
3. HANDI-STICK roof tile adhesive and its components shall be installed in accordance with Roofing Application Standard RAS 120, and Fomo Products, Inc. HANDI-STICK Operating Instruction and Maintenance Booklet
4. Installation must be by a Factory Trained 'Qualified Applicator' approved and licensed by Fomo Product, Inc.
5. Pressure treated wood filler block shall be required on all eave course of all tile profiles except on two pieces barrel tile.
6. Tiles must be adhered in freshly applied adhesive. Tile must be set within 4 minutes after Handi-Stick has been dispensed.
7. HANDI-STICK placement shall be in accordance with the 'Placement Details' herein. Each generic tile profile requires the specific placement noted herein.


All HANDI-STICK containers shall comply with the Standard Conditions listed herein.





PLACEMENT DETAIL # 1
