System:	“5-V-Crimp” Metal Panels
Deck Type:	Wood, Non-insulated
Deck Description:	$1\frac{9}{32}$ " or greater plywood or wood plank.
Slope Range:	2":12" or greater
Maximum Uplift Pressure:	See fastening options below

Deck Attachment: In accordance with applicable building code, but in no case it shall be less than # 8 x $1\frac{3}{4}$ " screws or 8d annular ring shank nails spaced at 6" o.c. In re-roofing, where deck is less than $1\frac{9}{32}$ " thick (minimum $1\frac{5}{32}$ ") the above attachment method must be in addition to existing attachment.

Underlayment: Minimum underlayment shall be an ASTM D 226 Type II installed with a minimum 4" side-lap and 6" end-laps. Underlayment shall be fastened with corrosion resistant tin-caps and 12 gauge x $1\frac{1}{4}$ " annular ring-shank nails, spaced 6" o.c. at all laps and two staggered rows 12" o.c. in the field of the roll. Or, any approved underlayment having a current NOA.

Valleys: Valley construction shall be in compliance with Roofing Application Standard RAS 133 and with current published installation instructions and details in Firestone Metal Products' Installation Manual.

Fire Barrier Board: Any approved fire barrier having a current NOA. Refer to a current fire directory listing for fire ratings of this roofing system assembly as well as the location of the fire barrier within the assembly. See Limitation # 1.

Metal Panels and Accessories: Install the "5-V-Crimp Panels" and accessories in compliance with the current published installation instructions and details in Firestone Metal Products' Installation Manual. Flashings, penetrations, valley construction and other details shall be constructed in compliance with Roofing Application Standard RAS133.

Fastening Option #1 Panel Overlaps and Center ribs are to be installed using #9 x 1-1/2" HWH Wood screws 1" from the panel end and maximum fastener spacing of 24" on center thereafter. (*Maximum Design Pressure, -82.25 psf. See System Limitation #2*)

Fastening Option #2 Panel Overlaps and Center ribs are to be installed using #9 x 1-1/2" HWH Wood screws 1" from the panel end and maximum fastener spacing of 12" on center thereafter. (*Maximum Design Pressure, -189.25 psf. See System Limitation #2*)

SYSTEM LIMITATIONS


1. Fire classification is not part of this acceptance; refer to a current Approved Roofing Materials Directory for fire ratings of this product.
2. The maximum designed pressure listed herein shall be applicable to all roof pressure zones (i.e. field, perimeters, and corners). Neither rational analysis, nor extrapolation shall be permitted for enhanced fastening at enhanced pressure zones (i.e. perimeters, extended corners and corners).
3. Panels may be rolls formed in continuous lengths from eave to ridge. Maximum lengths shall be as described in Roofing Application Standard RAS 133
4. All panels shall be permanently labeled with the manufacturer's name and/or logo, and the following statement: "Miami-Dade County Product Control Approved" or with the Miami-Dade County Product Control Seal as seen below. All clips shall be permanently labeled with the manufacturer's name and/or logo, and/or model.




5. All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule 9B-72 of the Florida Administrative Code.

"5-V-CRIMP" METAL ROOF PANELS




FASTENER PLACEMENT DETAIL
