PRODUCT DESCRIPTION

Fox Blocks Insulating Concrete Forms (ICFs) are made from ASTM C578-compliant Type II expanded polystyrene (EPS). The forms are used as stay-in-place form work for structural concrete, load-bearing and nonload-bearing, below-grade and above-grade walls. The forms are used in construction of plain and reinforced concrete beams, lintels, exterior and interior walls and foundation and retaining walls. The forms remain in place after placement and curing of concrete to provide wall insulation, and must be covered with approved interior and exterior finish materials in accordance with the Florida Building Code. The concrete forming system shall comply with ACI 347, and the concrete walls shall comply with ACI 318. The properties of EPS are listed below.
