## 1. SCOPE

This revises a roofing system using Entegra Valencia Spanish "S" Concrete Roof Tile, as manufactured by Entegra Roof Tile Inc. in Okeechobee, FL as described in Section 2 of this Notice of Acceptance, designed to comply with the Florida Building Code, for High Velocity Hurricane Zone. For the locations where the pressure requirements, as determined by applicable Building Code, does not exceed the design pressure values obtain by calculations in compliance with RAS 127 using the values listed in section 4 herein. The attachment calculations shall be done as a moment based system.

### 3. LIMITATIONS:

- 3.1 Fire classification is not part of this acceptance.
- 3.2 For mortar or adhesive set tile applications, a static field uplift test in accordance with TAS 106 may required, refer to applicable building code.
- 3.3 Applicant shall retain the services of a Miami-Dade County Certified Laboratory to perform quarterly test in accordance with TAS 112, appendix 'A'. Such testing shall be submitted to the Building and Neighborhood Compliance Department – Product Control Section for review.
- 3.4 Minimum underlayment shall be in compliance with the applicable Roofing Applications Standards listed section 4.1 herein.
- 3.5 30/90 hot mopped underlayment applications may be installed perpendicular to the roof slope unless stated otherwise by the underlayment material manufacturers published literature.
- 3.6 This acceptance is for wood deck applications. Minimum deck requirements shall be in compliance with applicable building code.



#### 4. INSTALLATION

- 4.1 Entegra Valencia Spanish "S" Concrete Roof Tile and its components shall be installed in strict compliance with Miami Dade County Roofing Application Standard RAS 118, RAS 119, and RAS 120.




ENTEGRA VALENCIA SPANISH 'S' TILE LABEL (LOCATED ON UNDERSIDE OF TILE)
