System A-1: SS-4-12 Snap Cap & CP-4-12
Deck Type: Wood, Non-insulated
Deck Description: New Construction $\frac{19}{32}$ " or greater plywood or wood plank.
Slope Range: 2": 12" or greater
Maximum Uplift Pressure: See Table A below. (See General Limitation #2)

Deck Attachment: In accordance with applicable building code, but in no case shall it be less than # 8 x 2" long screws spaced 6" o.c. In re-roofing, where the deck is less than $\frac{19}{32}$ " thick (Minimum $\frac{15}{32}$ ") the above attachment method must be in addition to existing attachment. (See footnote 1. in Table A below)

Underlayment: Minimum underlayment shall be an ASTM D 226 Type II installed with a minimum 4" side-lap and 6" end-laps. Underlayment shall be fastened with corrosion resistant tin-caps and 1 1/4" annular ring-shank nails, spaced 6" o.c. at all laps and two staggered rows 12" o.c. in the field of the roll.

Panel Clips: Panels shall be installed with approved clips, attached to substrate with one corrosion resistant #8-14 screws of sufficient length to penetrate through the sheathing $\frac{3}{16}$ " at a maximum spacing listed in **Table A** below. Once the clips are secured in place, the clip tabs are folded over and the snap cap is applied along the full length of the seam.

Valleys: Valley construction shall be in compliance with RAS 133 and with the current published installation instructions and details in Aeicor Metal Roofing Installation Manual.

Fire Barrier Board: Any approved fire barrier having a current NOA. Refer to a current fire directory listing for fire ratings of this roofing system assembly as well as the location of the fire barrier within the assembly. See Limitation # 1.

Metal Panels and Accessories: Install the "SS-4-12 Snap Cap Panel & CP-4-12" and accessories in compliance with the current published installation instructions and details in Aeicor Metal Roofing Installation Manual. Flashing, penetrations, valley construction and other details shall be constructed in compliance with RAS 133.

Deck Description: New Construction ¹⁹/₃₂" or greater plywood or wood plank.
Slope Range: 2": 12" or greater
Maximum Uplift Pressure: See Table B below. (See General Limitation #2)

Deck Attachment: In accordance with applicable building code, but in no case shall it be less than # 8 x 2" long ring shank nails spaced 6" o.c. In re-roofing, where the deck is less than ¹⁹/₃₂" thick (Minimum ¹⁵/₃₂") the above attachment method must be in addition to existing attachment.

Underlayment: Minimum underlayment shall be an ASTM D 226 Type II installed with a minimum 4" side-lap and 6" end-laps. Underlayment shall be fastened with corrosion resistant tin-caps and 1 1/4" annular ring-shank nails, spaced 6" o.c. at all laps and two staggered rows 12" o.c. in the field of the roll.

Panel Clips: Panels shall be installed with approved clips, attached to substrate with one corrosion resistant #8-14 screws of sufficient length to penetrate through the sheathing ³/₁₆" at a maximum spacing listed in **Table B** below. Once the clips are secured in place, the clip tabs are folded over and the snap cap is applied along the full length of the seam.

Valleys: Valley construction shall be in compliance with RAS 133 and with the current published installation instructions and details in Aeicor Metal Roofing Installation Manual.

Fire Barrier Board: Any approved fire barrier having a current NOA. Refer to a current fire directory listing for fire ratings of this roofing system assembly as well as the location of the fire barrier within the assembly. See Limitation # 1.

Metal Panels and Accessories: Install the "SS-4-12 Snap Cap Panel & CP-4-12" and accessories in compliance with the current published installation instructions and details in Aeicor Metal Roofing Installation Manual. Flashing, penetrations, valley construction and other details shall be constructed in compliance with RAS 133.

System B-1: SS-4-12 Snap Cap & CP-4-12
Deck Type: Steel, Non-insulated
Deck Description: New Construction 22 ga. type B steel roof deck.
Slope Range: 2": 12" or greater
Maximum Uplift Pressure: The maximum allowable uplift pressure for the 12- 3/4 "wide panel shall be -97.5 psf. (See General Limitation #2)

Deck Attachment: Minimum 22 gage type B steel deck fastened to steel supports at a maximum span of 5 feet o.c. Steel deck shall be fastened with minimum 5/16" puddle welds with 1 7/8" weld washer at a maximum spacing of 6" o.c. Side laps shall be fastened with #10 x 3/4" HH TEK screws.

Fire Barrier Board: 1/4" Dens Deck fastens to steel deck with approved insulation fasteners & 3" steel plate at a density of 1:4ft in accordance with RAS 117.

Any approved fire barrier having a current NOA. Refer to a current fire directory listing for fire ratings of this roofing system assembly as well as the location of the fire barrier within the assembly. See Limitation # 1.

Underlayment: A single layer of any Miami Dade County Product Control Approved self-adhered with a 4" overlap is fully adhered to Dens Deck.

Or

An ASTM D 226 type II installed with a minimum 4" side-lap and 6" en-laps. Underlayment fastened with approved insulation fasteners and plates. Spaced 12" o.c. on the laps and two rows spaced 24" o.c. in the field of roll.

Panel Clips: Panels shall be installed with approved clips, attached to substrate with one corrosion resistant #8 Wafer Head TEK screws of sufficient length to penetrate the bottom flute a minimum of 3/4" at a maximum spacing of 6 inches o.c. Once the clips are secured in place, the clip tabs are folded over and the snap cap is applied along the full length of the seam.

Valleys: Valley construction shall be in compliance with RAS 133 and with the current published installation instructions and details in Aeicor Metal Roofing Installation Manual.

Metal Panels and Accessories: Install the "SS-4-12 Snap Cap Panel & CP-4-12" and accessories in compliance with the current published installation instructions and details in Aeicor Metal Roofing Installation Manual. Flashings, penetrations, valley construction and other details shall be constructed in compliance with RAS 133.



SYSTEM LIMITATIONS


1. Fire classification is not part of this acceptance; refer to a current Approved Roofing Materials Directory for fire ratings of this product.
2. The maximum designed pressure listed herein shall be applicable to all roof pressure zones (i.e. field, perimeters, and corners). Neither rational analysis, nor extrapolation shall be permitted for enhanced fastening at enhanced pressure zones (i.e. perimeters, extended corners and corners).
3. Panels may be rolls formed in continuous lengths from eave to ridge. Maximum lengths shall be as described in Roofing Application Standard RAS 133
4. All panels shall be permanently labeled with the manufacturer's name and/or logo, and the following statement: "Miami-Dade County Product Control Approved" or with the Miami-Dade County Product Control Seal as seen below. All clips shall be permanently labeled with the manufacturer's name and/or logo, and/or model.



5. All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule 9B-72 of the Florida Administrative Code.
