7.1 Shingles shall be labeled with the Miami-Dade Product Control approved seal as seen below or the wording "Miami-Dade County Product Control Approved".




8. BUILDING PERMIT REQUIREMENTS

 - **8.1.2** Any other documents required by the Building Official or the applicable code in order to properly evaluate the installation of this system.




