SYSTEM A-1: Series 1101 Panel 16" Wide

Deck Type: Wood, Non-insulated

Deck Description: $^{19}/_{32}$ " or greater plywood or wood plank

Slope Range: 2":12" or greater

Maximum Uplift See Table A Below

Deck Attachment: In accordance with applicable building code, but in no case shall it be less than #8d annular

ring shank nails spaced 6" o.c. In reroofing, where the deck is less than $^{19}/_{32}$ " thick

(Minimum $^{15}/_{32}$ ") the above attachment method must be in addition to existing attachment.

Underlayment: Minimum underlayment shall be an ASTM D 226 Type II installed with a minimum 4" side-

lap and 6" end-laps. Underlayment shall be fastened with corrosion resistant tin-caps and 12 gauge 1 1/4" annular ring-shank nails, spaced 6" o.c. at all laps and two staggered rows 12"

o.c. in the field of the roll. Or, any approved underlayment having a current NOA.

Valleys: Valley construction shall be in compliance with Roofing Application Standard RAS 133 and

with Englert's current published installation instructions.

Fire Barrier Board: Any approved fire barrier having a current NOA. Refer to a current fire directory listing for

fire ratings of this roofing system assembly as well as the location of the fire barrier within

the assembly. See Limitation # 1.

Metal Panels and Accessories:

Install the "Series 1101 Panel" and accessories in compliance with the current published installation instructions and details in Englert Metal Roofing Installation Manual. Flashings, penetrations, valley construction and other details shall be constructed in compliance with Roofing Application Standard RAS 133.

- 1. Panels shall be secured at a spacing listed below in **Table A** with #10 pancake head screws of sufficient length to penetrate through the sheathing a minimum $^{3}/_{16}$ of an inch.
- 2. The adjacent panel shall overlap and be secured to each other with a snap-lock the full length of the panel.


