- **3.** The product listed herein are components of roof assemblies and are approved for use with roof assemblies that list any of the products listed herein as part of their roof assemblies Notice of Acceptance. If a product is not listed as part of roof assemblies Notice of Acceptance, a request may be made to the local building official or the Miami Dade Building Code Compliance Office for approval provided that appropriate documentation is provided.
- 4. All products listed herein shall have an unannounced follow-up quality control program from an approved listing agency, and shall have a quality assurance audit in accordance with the Florida Building Code and Rule 9N-3 of the Florida Administrative Code. Follow up test results shall be made available to Product Control upon request.
- 5. Change in materials, use, or manufacture of any of the products listed herein shall be cause for termination of this Notice of Acceptance.
- 6. This maintenance coating systems shall not be applied over, prepared roofing; i.e., fiber-cement shingles, quarry slate, cement or clay roof tile, metal shingles, wood shingles or shakes.
- 7. Tropical Roofing Products' products shall be applied in accordance with manufacturer's published application instructions.
- **8.** The use of a reinforcing fabric in a maintenance coating is only to enhance the coatings ability to deliver efficient and long term performance through the protection of the underlying roof system and in this particular use does not become a roof system itself.
- **9.** All approved products listed herein shall be labeled in compliance with TAS 121 and shall bear the imprint or identifiable marking of the manufacturer's name or logo and following statement: "Miami-Dade County Product Control Approved" or the Miami-Dade County Product Control Seal as shown below
