Field Conditions: Panels shall be secured along the male rib with approved panel clip (base and upper clip)

> with two corrosion resistant #10 pancake head fasteners of sufficient length to penetrate through the sheathing a minimum of $^{3}/_{16}$ ". The panel clips were placed at a spacing listed of

16" on center starting 3" from panel end. The female rib of panel is placed over the

male/clip assembly and seamed 180°. See Detail A herein.

Panels shall be secured along the male rib with approved continuous clip with two corrosion resistant #10 pancake head fasteners of sufficient length to penetrate through the sheathing a minimum of $\frac{3}{16}$ " at 12" o.c. The upper clip placement along the continuous clip is at 12" o.c. The female rib of panel is placed over the male/clip assembly and seamed 180°. See

- **3.** Panels may be rolls formed in continuous lengths from eave to ridge. Maximum lengths shall be as described in Roofing Application Standard RAS 133
- 4. All panels shall be permanently labeled with the manufacturer's name and/or logo, and the following statement: "Miami-Dade County Product Control Approved" or with the Miami-Dade County Product Control Seal as seen below. All clips shall be permanently labeled with the manufacturer's name and/or logo, and/or model.




- 5. All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule 9N-3 of the Florida Administrative Code.
- **6.** Panels may be jobsite roll formed with machine model <u>#9600406</u> from DMC Association of Regional Manufacturers.







PANEL CLIP





CONTINUOUS CLIP
