- For application over spray polyurethane foam system apply a base coat at a minimum rate of 1.25 gal/100 sq. ft., an intermediate coat at a minimum rate of 1.25 gal/100 sq. ft and a top coat at a rate of 1.25 gal/100 sq. ft.
- For application over galvanized metal roof apply a base coat at a minimum rate of 1 gal/100sq.ft. and a top coat of 1 gal/100 sq. ft.

Container Sizes: 1 & 55 gallons. Note all cautions on container label.

Systems Approvals: Methods of application and quantities shall comply with the specific Roof Assembly System’s Product Control Notice of Acceptance where it exceeds standards of this NOA.

5. All products listed herein shall have an unannounced follow-up quality control program from an approved listing agency. Follow up test results shall be made available to Miami Dade Product Control upon request.
