**APPROVED USES:**

TPO Cover Tape may be used as a flashing accessory piece with TPO roofing systems only where it is applied as a secondary membrane over an existing approved TPO membrane. The performance of the accessory piece is not affected by the deck type, insulation or coverboard sub-assemblies. The TPO Cover Tape shall be in contact with the TPO field membrane and other surface materials as indicated in usage applications below:

1. Metal edge tie-in to TPO field membrane.
2. Various roof repairs over existing TPO field membrane.
3. Cover for mechanical fastening bars, membrane fasteners, core sample repair patches.

**INSTALLATION:**

TPO Cover Tape shall be applied to a smooth, clean and dry surface that has been prepared and/or primed as specified by the approved TPO system roofing manufacturer's published application guidelines.

**LIMITATIONS:**

1. Fire classification is not part of this acceptance.
2. The cover tape will be used only as a secondary membrane in conjunction with an existing approved TPO field membrane.
3. TPO Cover Tape may be used with any approved TPO roof covering Notice of Acceptance listing TPO Cover Tape as a component part of an assembly in the Notice of Acceptance. If TPO Cover Tape is not listed, a request may be made to the Authority Having Jurisdiction (AHJ) or the Miami-Dade County Product Control Department for approval provided that appropriate documentation is provided to detail compatibility of the products.
4. All membranes or packaging shall bear the imprint or identifiable marking of the manufacturer's name or logo, city, state and the following statement: "Miami-Dade County Product Control Approved" or the Miami-Dade County Product Control Seal as shown below.
