- **Spray Polyurethane Foam Systems:** Apply with brush, roller or spray in two coats at a minimum rate of 1.5gal/100ft<sup>2</sup> per coat for a total coverage of 3.0gal/100ft<sup>2</sup>.
- **Single Ply TPO** Apply with brush, roller or spray in two coats at a minimum rate of 1.5gal/100ft<sup>2</sup> per coat for a total coverage of 3.0gal/100ft<sup>2</sup>.
- **Single Ply PVC** Apply with brush, roller or spray in two coats at a minimum rate of 1.5gal/100ft<sup>2</sup> per coat for a total coverage of 3.0gal/100ft<sup>2</sup>.
- **Single Ply KEE** Apply with brush, roller or spray in two coats at a minimum rate of 1.5gal/100ft<sup>2</sup> per coat for a total coverage of 3.0gal/100ft<sup>2</sup>.
- **Single Ply Hypalon** Apply with brush, roller or spray in two coats at a minimum rate of 1.5gal/100ft<sup>2</sup> per coat for a total coverage of 3.0gal/100ft<sup>2</sup>.
- **Metal PVDF (Kynar coated Metal)** Apply with brush, roller or spray in two coats at a minimum rate of 1.5gal/100ft<sup>2</sup> per coat for a total coverage of 3.0gal/100ft<sup>2</sup>.
- **Galvanized Metal Roof:** Apply with brush, roller or spray in two coats at a minimum rate of 1.5gal/100ft<sup>2</sup> per coat for a total coverage of 3.0gal/100ft<sup>2</sup>.
- **Galvalume:** Apply with brush, roller or spray in two coats at a minimum rate of 1.5gal/100ft<sup>2</sup> per coat for a total coverage of 3.0gal/100ft<sup>2</sup>.

**Container Sizes:** 5 gallon pail & 55 gallon drum. Note all cautions on container label.

**Systems Approvals:** Methods of application and quantities shall comply with the specific Roof Assembly System's Product Control Notice of Acceptance where it exceeds standards of this NOA.

4. All products listed herein shall have an unannounced follow-up quality control program from an approved listing agency. Follow up test results shall be made available to Miami Dade Product Control upon request.
5. Change in materials, use, or manufacture of any products listed herein shall be cause for termination of this Notice of Acceptance.
6. CertainTeed FlintCoat-W shall be applied in accordance with manufacturer's published application instructions.
7. All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule 61G20-3 of the Florida Administrative Code.
8. The use of a reinforcing fabric in a maintenance coating is only to enhance the coating's ability to deliver efficient and long term and performance through the protection of the underlying roof system and in this particular use does not become a roof system itself.

All approved products listed herein shall be labeled in compliance with TAS 121 and shall bear the imprint or identifiable marking of the manufacturer's name or logo, city and state of manufacturing facility, and following statement: "Miami-Dade County Product Control Approved" or the Miami-Dade County Product Control Seal as shown below.
