3. Minimum underlayment shall be in compliance with the Roofing Application Standard RAS 120.
4. Roof Tile manufactures acquiring acceptance for the use of 3M Foam Roof Tile Adhesive RTA-1 roof tile adhesive with their tile assemblies shall test in accordance with TAS 101 with section 10.4 as modified herein.

5. All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule 61G20-3 of the Florida Administrative Code.



INSTALLATION:

1. 3M Foam Roof Tile Adhesive RTA-1 may be used with any roof tile assembly having a current NOA that lists attachment resistance values with the use of 3M Foam Roof Tile Adhesive RTA-1.
2. 3M Foam Roof Tile Adhesive RTA-1 shall be applied in compliance with the Component Application section and the corresponding Placement Details noted herein. The roof tile assembly’s adhesive attachment with the use of 3M Foam Roof Tile Adhesive RTA-1 shall provide sufficient attachment resistance to meet or exceed the resistance values determined in compliance with Roofing Application Standards RAS 127. The adhesive attachment data is noted in the roof tile assembly NOA.
3. 3M Foam Roof Tile Adhesive RTA-1 roof tile adhesive and its components shall be installed in accordance with Roofing Application Standard RAS 120, and Fomo Products, Inc. 3M Foam Roof Tile Adhesive RTA-1 Operating Instruction and Maintenance Booklet
4. Installation must be by a Factory Trained 'Qualified Applicator' approved and licensed by Polyfoam Products, Inc.
5. Tiles must be adhered in freshly applied adhesive. Tile must be set within 4 minutes after 3M Foam Roof Tile Adhesive RTA-1 has been dispensed.
6. 3M Foam Roof Tile Adhesive RTA-1 placement shall be in accordance with the 'Placement Details' herein. Each generic tile profile requires the specific placement noted herein.

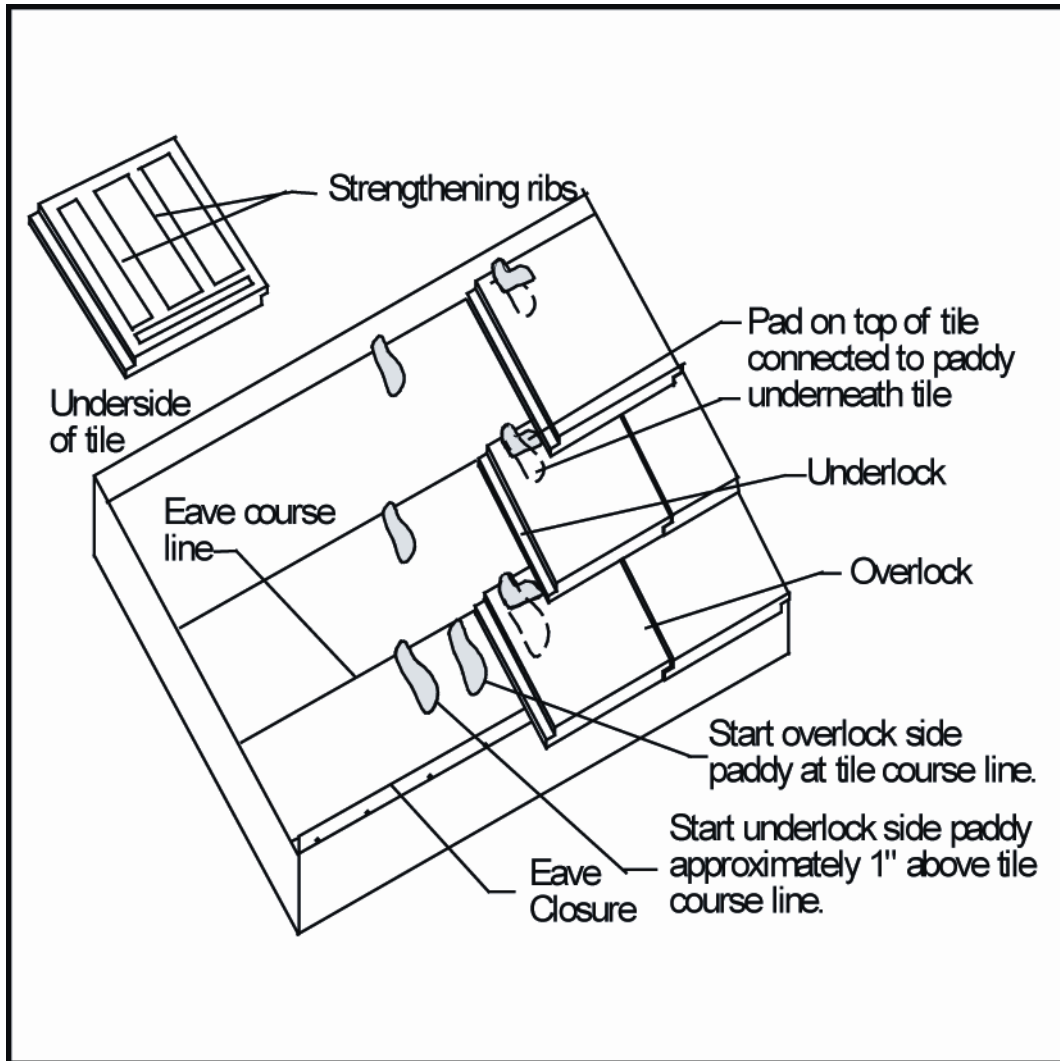

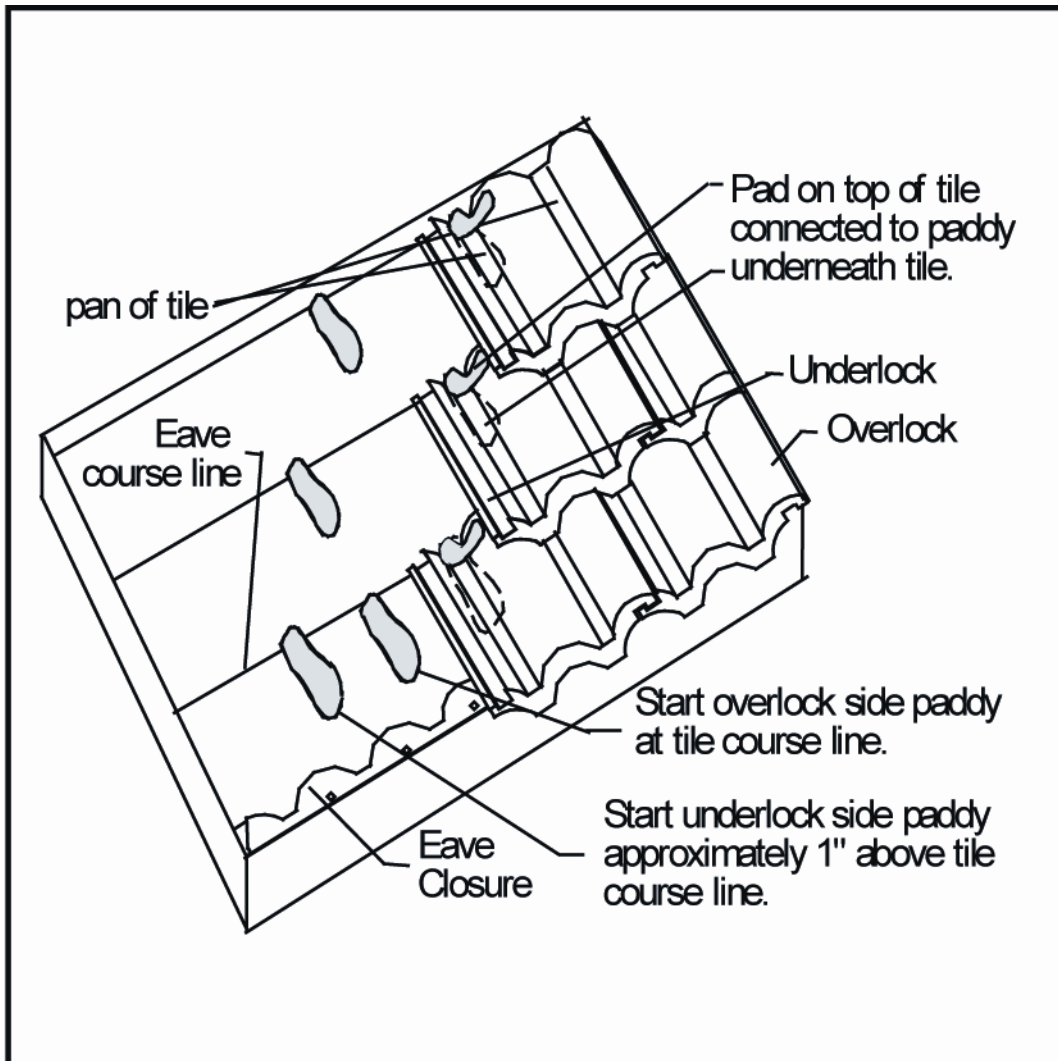

PLACEMENT DETAIL # 1



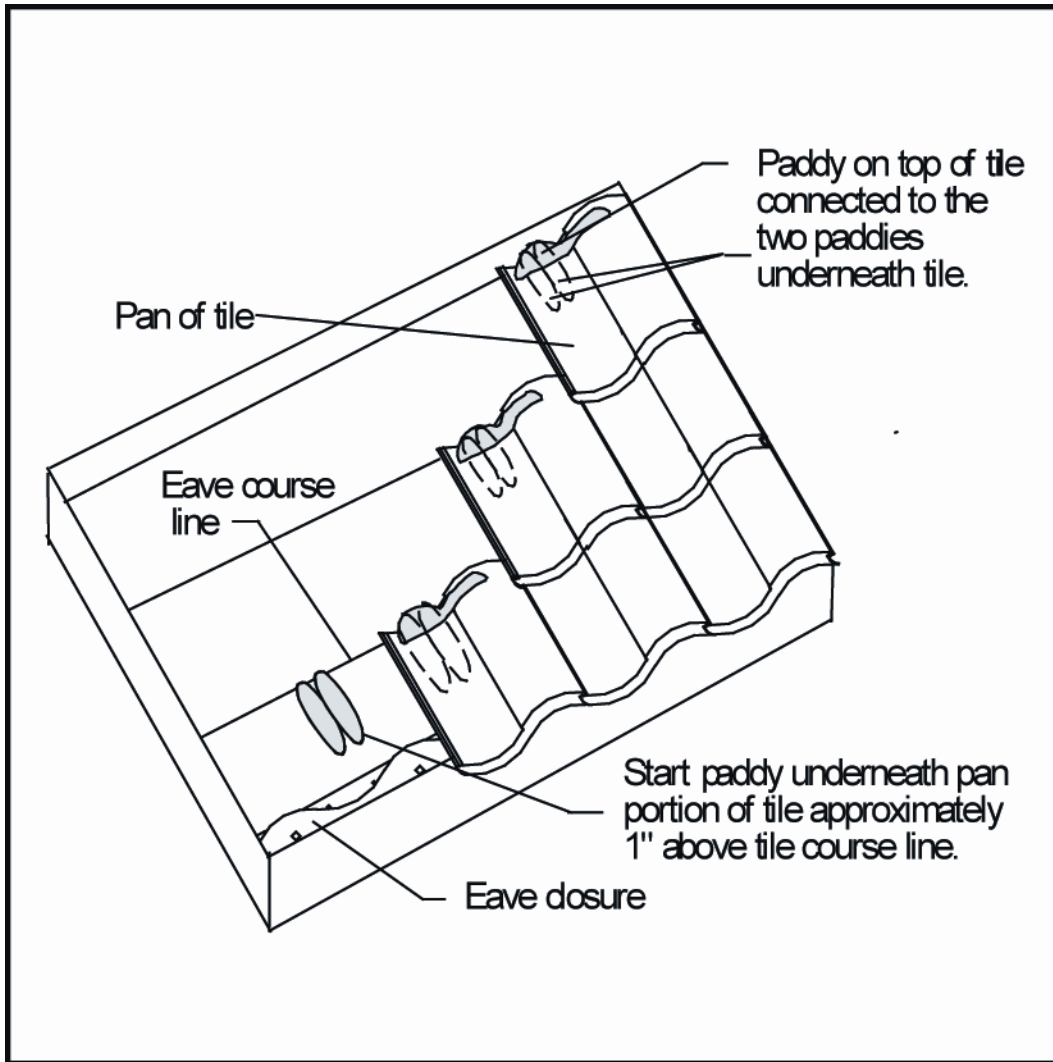
FLAT PROFILE

PLACEMENT DETAIL # 1 (CONT...)



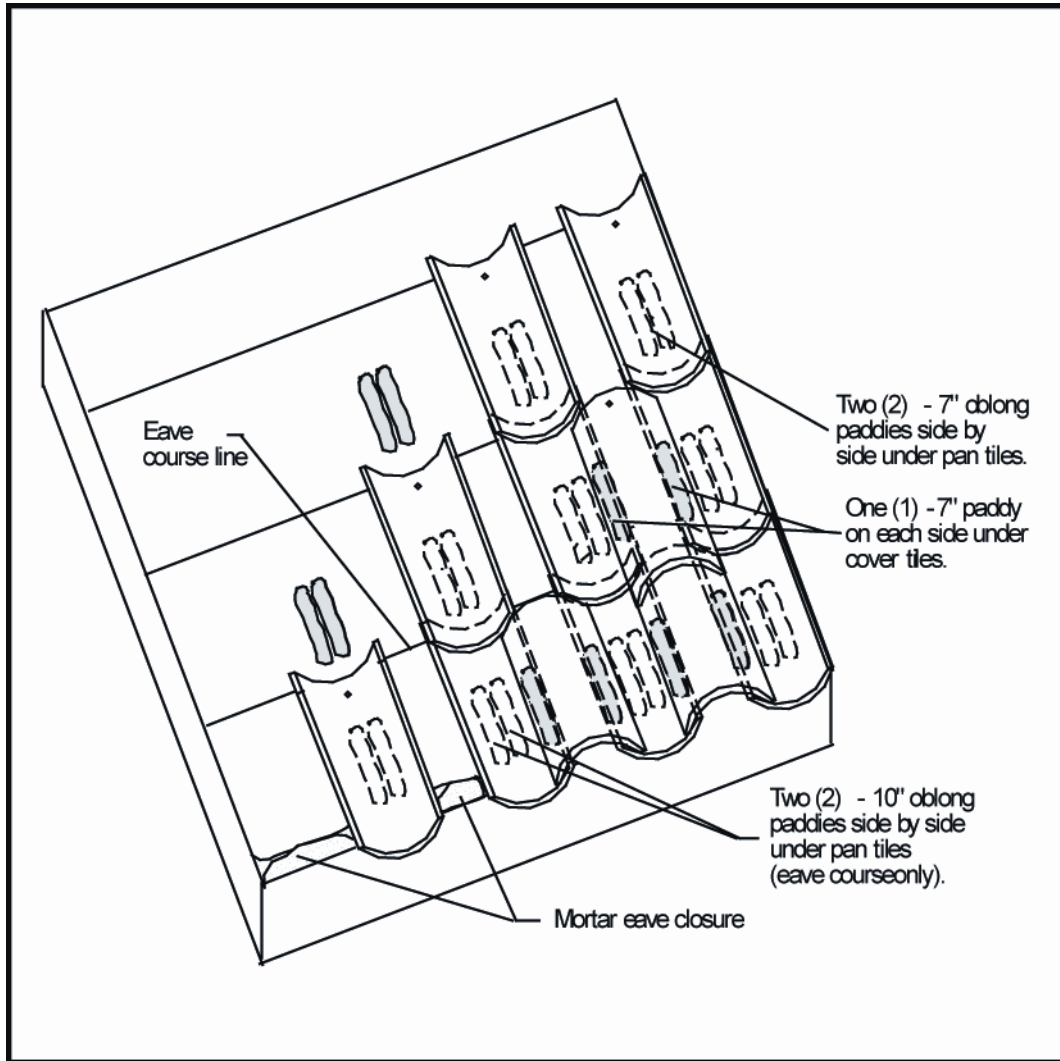
LOW PROFILE
