APPROVED USES:

FTR Non-Reinforced, FTR Cones, FTR Corners, FTR Wrapid Flash, FiberClad and FiberTite Simulated Metal Roof Profile may be used as a flashing accessory piece with KEE roofing systems only where it is applied as a secondary material over an existing approved KEE membrane. The performance of the accessory piece is not affected by the deck type, insulation or coverboard sub-assemblies.

INSTALLATION:

FTR Non-Reinforced, FTR Cones, FTR Corners, FTR Wrapid Flash, FiberClad and FiberTite Simulated Metal Roof Profile shall be applied to a smooth, clean and dry surface that has been prepared as specified by the approved KEE system roofing manufacturer's published application guidelines.

LIMITATIONS:

1. Fire classification is not part of this acceptance.
2. The FiberTite Roofing Accessories will be used only as a secondary material in conjunction with an existing approved KEE field membrane.
3. The FiberTite Roofing Accessories may be used with any approved KEE roof covering Notice of Acceptance listing FTR Non-Reinforced, FTR Cones, FTR Corners, FTR Wrapid Flash, FiberClad and FiberTite Simulated Metal Roof Profile as a component part of an assembly in the Notice of Acceptance. If FTR Non-Reinforced, FTR Cones, FTR Corners, FTR Wrapid Flash, FiberClad and FiberTite Simulated Metal Roof Profile are not listed, a request may be made to the Authority Having Jurisdiction (AHJ) or the Miami-Dade County Product Control Department for approval provided that appropriate documentation is provided to detail compatibility of the products.
4. All component materials or packaging shall bear the imprint or identifiable marking of the manufacturer's name or logo, city, state and the following statement: "Miami-Dade County Product Control Approved" or the Miami-Dade County Product Control Seal as shown below.
