### SCOPE:

This approves “ELASTOTITE G 20140” roof adhesive, manufactured by BASF Corporation as described in this Notice of Acceptance, to be used and designed to comply with the Florida Building Code and the High Velocity Hurricane Zone of the Florida Building Code. The use of this acceptance is limited to those roof assemblies where ELASTOTITE G 20140 Adhesive is specifically listed as an accepted component.

Spray polyurethane adhesive consisting of two components (component a “Elastotite G 20000” and Component B “Elastotite G 20140) applied at a ratio of 1:1 with the properties described below:
