**Deck Attachment:** In accordance with applicable Building Code, but in no case shall it be less than 8d annular

ring shank nails spaced 6" o.c. In reroofing, where the deck is less than  $^{19}/_{32}$ " thick (Minimum  $^{15}/_{32}$ "). The above attachment method must be in addition to existing

attachment.

**Underlayment:** Minimum underlayment shall be a ASTM D 226 Type II installed with a minimum 4" side-

laps and 6" end-laps. Underlayment shall be fastened with corrosion resistant tin-caps and 11/4" annular ring-shank nails, spaced 6" o.c. at all laps and two staggered rows 12" o.c. in the field of the roll. Or, any Miami-Dade County Product Control Approved underlayment

having a current NOA.

**Fire Barrier Board:** Any approved fire barrier having a current NOA. Refer to a current fire directory listing for

fire ratings of this roofing system assembly as well as the location of the fire barrier within

the assembly. See Limitation #1.

Valleys: Valley construction shall be in compliance with Roofing Application Standard RAS 133

and with McElroy Metal, Inc.'s current published installation instructions.

Metal Panels and Accessories:

Install the "Maxima 216 24ga. Panels" and accessories in compliance with McElroy Metal Inc's current, published installation instructions and details. Flashing, penetrations, valley construction and other details shall be constructed in compliance with the minimum requirements provided in Roofing Application Standards RAS 133.

- 1. Panels shall be installed with approved clips as shown in **Detail B** and shall be at a maximum spacing as listed below in **Table A**.
- 2. Clips are to be attached to substrate with (2) two corrosion resistant #14-10 screws in all roof areas. (i.e. field, perimeter and corner). Fasteners shall be of sufficient length to penetrate through the sheathing a minimum of <sup>3</sup>/<sub>16</sub>".
- 3. Seam panels with a mechanical seaming tool.

Valleys: Valley construction shall be in compliance with Roofing Application Standard RAS 133

and with McElroy Metal, Inc.'s current published installation instructions.

Metal Panels and Accessories:

Install the "Maxima 216 24ga. Panels" and accessories in compliance with McElroy Metal Inc's current, published installation instructions and details. Flashing, penetrations, valley construction and other details shall be constructed in compliance with the minimum requirements provided in Roofing Application Standards RAS 133.

- 1. Panels shall be installed with approved clips as shown in **Detail C** and shall be at a maximum spacing as listed below in **Table B**.
- 2. Clips are to be attached to substrate with (2) two corrosion resistant #12-13 self drilling screws in all roof areas with a 4" x 6" x 16"ga metal bearing plate under each clip. (i.e. field, perimeter and corner). Fasteners shall be of sufficient length to penetrate through the sheathing a minimum of <sup>3</sup>/<sub>16</sub>".
- 3. Seam panels with a mechanical seaming tool.

- 2. The maximum designed pressure listed herein shall be applicable to all roof pressure zones (i.e. field, perimeters, and corners). Neither rational analysis, nor extrapolation shall be permitted for enhanced fastening at enhanced pressure zones (i.e. perimeters, extended corners and corners).
- **3.** Panels may be rolls formed in continuous lengths from eave to ridge. Maximum lengths shall be as described in Roofing Application Standard RAS 133
- 4. All panels shall be permanently labeled with the manufacturer's name and/or logo, and the following statement: "Miami-Dade County Product Control Approved" or with the Miami-Dade County Product Control Seal as seen below. All clips shall be permanently labeled with the manufacturer's name and/or logo, and/or model.



5. All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule 61G20-3 of the Florida Administrative Code.





# MAXIMA 216 24 GA. PANEL (N.T.S.)




PANEL CLIP (N.T.S.)




SYSTEM A AND SEAM DETAIL (N.T.S.)
