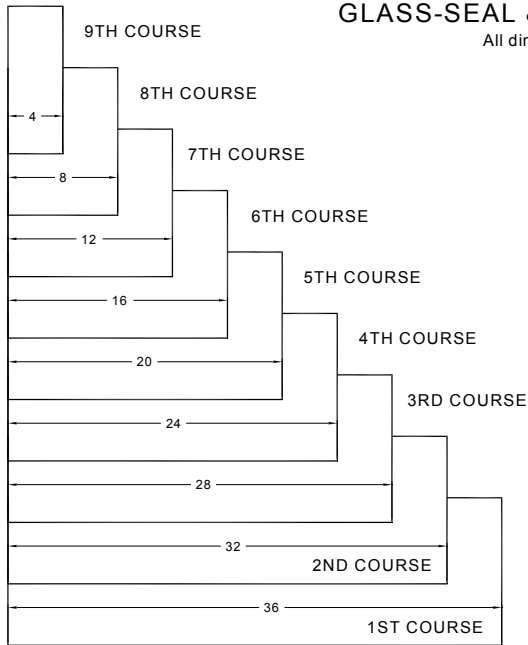

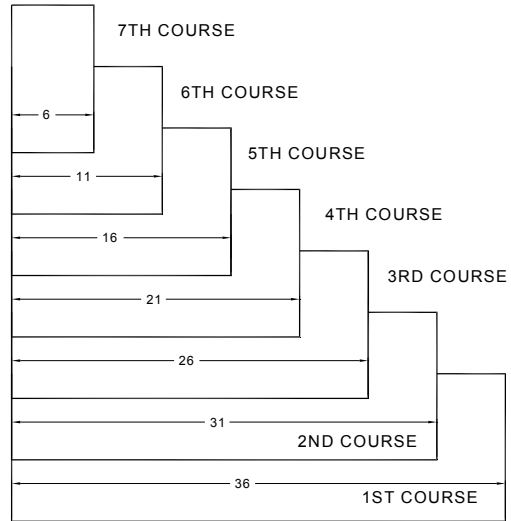
DETAIL A COURSE LAYOUT

GLASS-SEAL & ELITE GLASS-SEAL

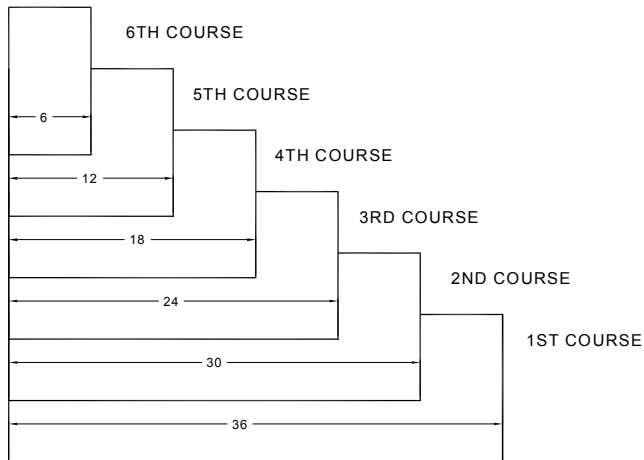

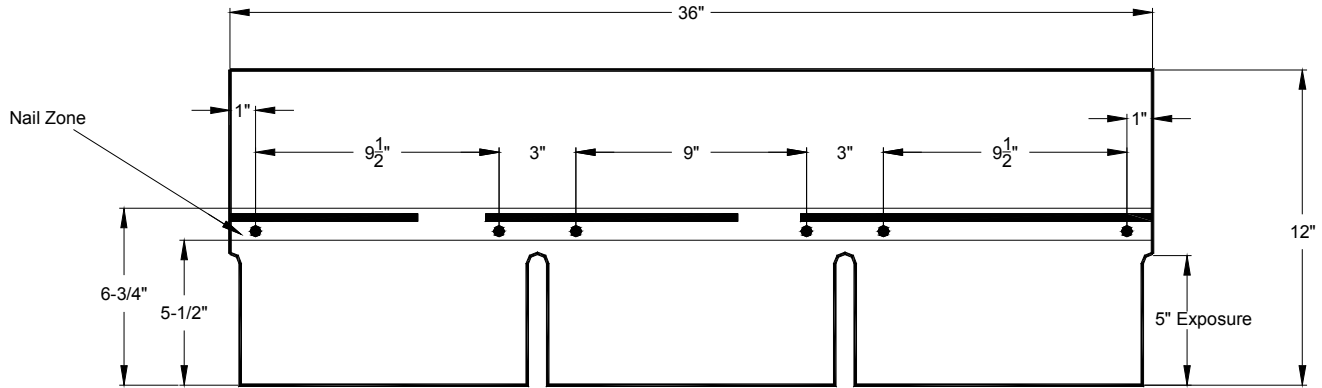

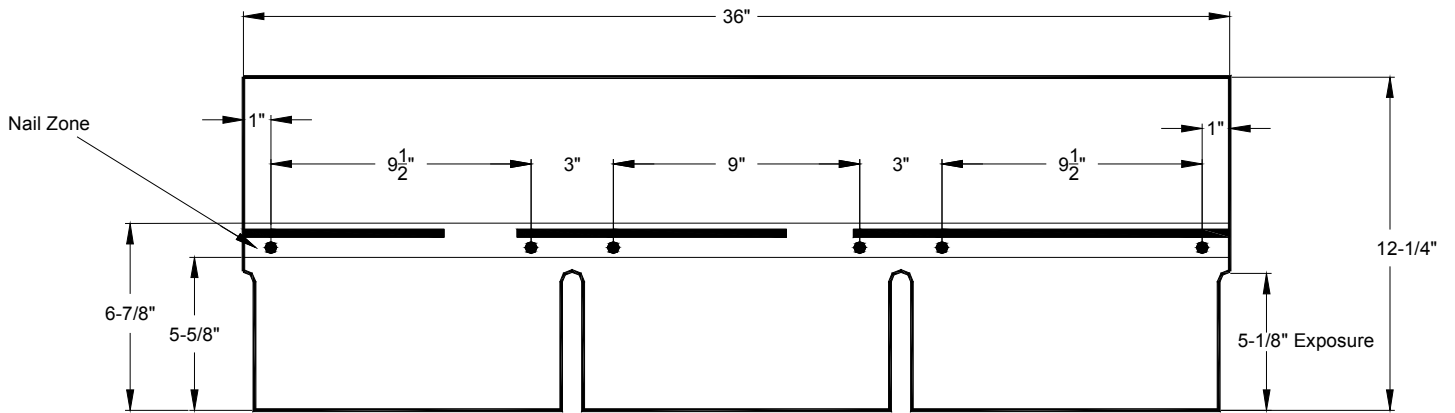
