3. LIMITATIONS

- 3.1 Fire classification is not part of this acceptance.
- For mortar or adhesive set tile applications, a static field uplift test shall be performed in accordance with 3.2 TAS 106.
- Applicant shall retain the services of a Miami-Dade County Certified Laboratory to perform quarterly test 3.3 in accordance with TAS 112, appendix 'A'. Such testing shall be submitted to the Building Code Compliance Office for review.
- 3.4 Minimum underlayment shall be in compliance with the applicable Roofing Applications Standards listed section 4.1 herein.
- 30/90 hot mopped underlayment applications may be installed perpendicular to the roof slope unless stated 3.5 otherwise by the underlayment material manufacturers published literature.
- This acceptance is for wood deck applications. Minimum deck requirements shall be in compliance with applicable building code.

4. Installation

- Mission Clay Tile and its components shall be installed in strict compliance with Roofing Application Standard RAS 120.


