ft o.c. with <u>one (1)</u> #12 x $1-\frac{1}{2}$ " Hex Washer Head self drilling screws fastened at the bottom of each flute (6" o.c.). Deck sidelaps shall be fastened 6" o.c. with #12 x $1-\frac{1}{2}$ " Hex Head

self drilling screws.

Insulation: Minimum ³/₄" thick and Maximum 4" thick of an approved rigid board insulation with

current NOA having a minimum 25psi compressive strength fastened with approved fasteners and plates. Fastening density shall be in compliance with applicable Building

Code and Roofing Application Standard RAS 117.

Underlayment: Minimum underlayment shall be an ASTM D 226 Type II installed with a minimum 4"

side-lap and 6" end-laps. Underlayment shall be fastened with corrosion resistant tin-caps and 12 gauge fasteners long enough to penetrate the steel deck, spaced 6" o.c. at all laps and two staggered rows 12" o.c. in the field of the roll or any approved underlayment having a

current NOA.

Fire Barrier Board: Any approved fire barrier having a current NOA. Refer to a current fire directory listing for

fire ratings of this roofing system assembly as well as the location of the fire barrier within

the assembly. See Limitation # 1.

Valleys: Valley construction shall be in compliance with Roofing Application Standard RAS 133

and with Metal Sales Manufacturing Corporation's current published installation

instructions.

Metal Panels and Accessories:

Install the Magna-Loc 16" 24ga Steel Non-Structural Roof Panel" including flashing penetrations, valleys, end laps and accessories in compliance "DMC Association of Regional Manufacturers" current, published installation instructions and in compliance with the minimum requirements detailed in Roofing Application Standard RAS 133.

Panels shall be installed with approved "Magna-Loc Two-Piece Clips" over the male rib side lap spaced at a maximum listed in Table A below, parallel to the roof slope, fastened with two (2) #14-13 screws of sufficient length for minimum ½" penetration through the structural deck. All clips shall be placed on top of a the 4" x 5" x 20ga. bearing plate over the insulation. Install the adjacent panel with the female end over the male and clip seam. Seam the panels with a mechanical seamer to form a 90° seam.



MAGNA-LOC 16" WIDE 24 GA. ROOF PANELS




MAGNA-LOC TWO-PIECE CLIP
