Panels shall be secured at a spacing listed below in **Table A** with corrosion resistant #10-13 x 1" pancake head screws of sufficient length to penetrate through the sheathing a minimum

 $\frac{3}{16}$  of an inch.

The adjacent panel shall overlap and be secured to each other when The female rib of panel

is snapped over the male rib of panel.

All panels shall be permanently labeled with the manufacturer's name and/or logo, city, state, and the following statement: "Miami-Dade County Product Control Approved" or with the Miami-Dade County Product Control Seal as seen below. All clips shall be permanently labeled with the manufacturer's name and/or logo, and/or model.




- **5.** All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule **61G20-3** of the Florida Administrative Code.


