Flashing, penetrations, valley construction and other details shall be constructed in compliance with the minimum requirements provided in Roofing Application Standards RAS

133.

Panels shall be fastened with corrosion resistant #10 HWH screws of sufficient length to penetrate through the sheathing a minimum of ³/₁₆". Fasteners shall be installed parallel to the roof slope along the panel's overlapping ribs (fastening of the center rib is optional) at a

maximum spacing as listed in **Table A** below.

- 2. The maximum designed pressure listed herein shall be applicable to all roof pressure zones (i.e. field, perimeters, and corners). Neither rational analysis, nor extrapolation shall be permitted for enhanced fastening at enhanced pressure zones (i.e. perimeters, extended corners and corners).
- **3.** Panel shall be roll formed in continuous lengths from eave to ridge. Maximum lengths shall be described in the Roofing Application Standard RAS 133. HORIZONTAL LAPS ARE PERMITTED
- **4.** All panels shall be permanently labeled with the manufacturer's name and/or logo, city and state of manufacturing facility, and the following statement: "Miami-Dade County Product Control Approved" **or** with the Miami-Dade County Product Control Seal as seen below. All clips shall be permanently labeled with the manufacturer's name and/or logo, and/or model.



- **5.** All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule 61G20-3 of the Florida Administrative Code.
- **6.** Panels may be shop or jobsite roll formed with machine model #'s <u>7090201 and Q4110340</u> from PAC Contractors Association.





