Valleys: Valley construction shall be in compliance with Roofing Application Standard RAS 133

and with the current published installation instructions and details in DMC Association of

Regional Manufacturers Installation Manual.

Install the "Snap Lock 24 gauge Steel Metal Panel" panels including flashing penetrations, **Metal Panels and Accessories:** 

valleys, end laps and accessories in compliance "DMC Association of Regional Manufacturers" current, published installation instructions and in compliance with the

minimum requirements detailed in Roofing Application Standard RAS 133.

Panels shall be secured along the male rib with approved clips and two corrosion resistant #10 pancake head fasteners of sufficient length to penetrate through the sheathing a minimum of  $\frac{3}{16}$ ". The panel clips were placed at a spacing listed in **Table A** below starting 3" from panel end. The female rib of panel is snapped over the male rib of panel.

- **3.** Panels may be rolls formed in continuous lengths from eave to ridge. Maximum lengths shall be as described in Roofing Application Standard RAS 133
- **4.** All panels shall be permanently labeled with the manufacturer's name and/or logo, city and state, and the following statement: "Miami-Dade County Product Control Approved" **or** with the Miami-Dade County Product Control Seal as seen below. All clips shall be permanently labeled with the manufacturer's name and/or logo, and/or model.




- 5. All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule 61G20-3 of the Florida Administrative Code.
- **6.** Panels may be jobsite roll formed with machine model # **SSQ8691118** from DMC Association of Regional Manufacturers.


