- 2. Fire classification is not part of this acceptance; refer to a current Approved Roofing Materials Directory for fire rating of this product.
- 3. All products shall be applied in strict compliance with Manufacturer's published application instructions.
- 4. Instacoat Seamless Membrane, Premium Liquid Rubber Seamless Membrane or IWS Seamless Membrane products shall not be applied in inclement weather conditions.
- 5. Instacoat Seamless Membrane, Premium Liquid Rubber Seamless Membrane or IWS Seamless Membrane shall <u>not</u> be applied as a roofing or waterproofing system. It is to be utilized as a maintenance coating component only.
- 6. Instacoat Seamless Membrane, Premium Liquid Rubber Seamless Membrane or IWS Seamless Membrane shall not be covered with stone chips, screeds, tiles or soil.
- 7. Instacoat Seamless Membrane, Premium Liquid Rubber Seamless Membrane or IWS Seamless Membrane shall not be applied over existing gravel surfaces.
- 8. All products listed herein shall have an unannounced follow-up quality control program from an approved listing agency. Follow up test results shall be made available to Miami-Dade Product Control upon request.
- 9. The products listed herein are components of roof assemblies and are approved for use with roof assemblies that list any of the products listed herein as part of their roof assemblies Notice of Acceptance. If a product is not listed as part of roof assemblies Notice of Acceptance, a request may be made to the Authority Having Jurisdiction (AHJ) or Miami Dade Product Control for approval provided that appropriate documentation is provided.
- 10. Change in materials, use, or manufacture of any of the products listed herein shall be cause for termination of this Notice of Acceptance.
- 11.
