**TPO Membranes:** Apply two coats at a minimum rate of 1.5 gal. /100 ft<sup>2</sup> per coat to yield an average total thickness of 48 wet mils or 36 DFT.

• Granule Surfaced APP or SBS Modified Bitumen: Apply two coats at a minimum rate of 1.5 gal. /100 ft<sup>2</sup> per coat to yield an average total thickness of 48 wet mils or 36 DFT.

**Container Sizes:** 5 and 55 gallons. Note cautions on container label.

- 7. The use of a reinforcing fabric in a maintenance coating is only to enhance the coating's ability to deliver efficient and long term performance through the protection of the underlying roof system and in this particular use does not become a roof system itself.
- 8. All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule 61G20-3 of the Florida Administrative Code.
- All approved products listed herein shall be labeled in compliance with TAS 121 and shall bear the imprint or 9. identifiable marking of the manufacturer's name or logo, city and state of manufacturing facility, and the following statement: "Miami-Dade County Product Control Approved" or the Miami-Dade County Product Control Seal as shown below.
