<b>Deck Type 3:</b>	Concrete Decks, Non-Insulated
<b>Deck Description:</b>	2,500 psi structural concrete or concrete plank
<b>System Type 1:</b>	Membranes adhered to primed substrate.
<b>Substrate Preparation:</b>	All surfaces must be dry, smooth, free of depressions, voids and protrusions, and clean and free of any non-compatible curing compounds, foam release agents and other surface contaminants.
<b>Flashing:</b>	Shall be in accordance with Garland published specifications.
<b>Primer:</b>	Concrete deck shall be primed with Dura-Walk Primer or Dura-Walk FC Primer applied at a rate of 0.5 gal./100 ft <sup>2</sup> and allowed to dry prior to the application of base coat.
<b>Base Layer:</b>	Dura-Walk Base Coat applied at a rate of 1-1.5 gal./100 ft <sup>2</sup> (20 mils wet) and allow to dry overnight.
<b>Intermediate Coat:</b>	Dura-Walk Wear Coat applied at a rate of 1-1.5 gal./100 ft <sup>2</sup> (24 mils wet). Immediately broadcast 6 to 8 lbs./100 ft <sup>2</sup> of aggregate, uniformly into wet coating for even distribution. Allow to dry for the minimum time specified and sweep away loose aggregate prior to application of top coat.
<b>Top Coat:</b>	Dura-Walk Top Coat applied at a rate of 1 gal./100 ft <sup>2</sup> (16 mils wet) and allowed to dry.
<b>Integrity Test:</b>	Required, and shall be performed in accordance with ASTM D 5957 by an approved lab. Water may be maintained for a period longer than 24 hours if required.
<b>Inspection:</b>	Contractor and a representative of the membrane manufacturer shall inspect the waterproofing assembly and notify the contractor of any defects. Inspection must take place prior to installation of any overlay insulation, protection pads, drainage boards or traffic surfacing. All defects observed shall be corrected.
<b>Surfacing:</b>	None
<b>Maximum Design Pressure:</b>	-1,025 psf (See General Limitation #9.)

<b>Flashing:</b>	Shall be in accordance with Garland published specifications.
<b>Primer:</b>	Concrete deck shall be primed with Dura-Walk Primer or Dura-Walk FC Primer applied at a rate of 0.5 gal./100 ft <sup>2</sup> and allowed to dry prior to the application of base coat.
<b>Base Layer:</b>	Dura-Walk Base Coat applied at a rate of 1-1.5 gal./100 ft <sup>2</sup> (20 mils wet) and allow to dry overnight.
<b>Intermediate Coat:</b>	Dura-Walk Wear Coat applied at a rate of 1-1.5 gal./100 ft <sup>2</sup> (24 mils wet). Immediately broadcast 6 to 8 lbs./100 ft <sup>2</sup> of aggregate, uniformly into wet coating for even distribution. Allow to dry for the minimum time specified and sweep away loose aggregate. Apply a second coat of Dura-Walk Wear Coat as noted above. Allow to dry for the minimum time specified and sweep away loose aggregate prior to application of top coat.
<b>Top Coat:</b>	Dura-Walk Top Coat applied at a rate of 1 gal./100 ft <sup>2</sup> (16 mils wet) and allowed to dry.
<b>Integrity Test:</b>	Required, and shall be performed in accordance with ASTM D 5957 by an approved lab. Water may be maintained for a period longer than 24 hours if required.
<b>Inspection:</b>	Contractor and a representative of the membrane manufacturer shall inspect the waterproofing assembly and notify the contractor of any defects. Inspection must take place prior to installation of any overlay insulation, protection pads, drainage boards or traffic surfacing. All defects observed shall be corrected.
<b>Surfacing:</b>	None
<b>Maximum Design Pressure:</b>	-1,025 psf (See General Limitation #9.)



## GENERAL LIMITATIONS:

1. Fire classification is not part of this acceptance, refer to a current Approved Roofing Materials Directory for fire ratings of this product.
2. Required integrity flood testing shall be provided to the Building Official for review at time of final inspection.
3. All work shall be performed by a Contractor licensed to do roofing/waterproofing and be a Manufacturer Trained 'Qualified Applicator' approved by The Garland Company. The Garland Company shall supply a list of approved applicators to the authority having jurisdiction.
4. Flashings shall be installed according to the manufacturer's published standard details and shall be submitted to the Building Official for review.
5. Contractor shall submit to the Building Official for review the system specifications and details. Submission of these documents, as well as the proper application and installation of all materials shall be the sole responsibility of the contractor.
6. All attachment and sizing of perimeter nailers, metal profile, and/or flashing termination designs shall conform with Roofing Application Standard RAS 111 and the wind load requirements of applicable Building Code.
7. Perimeter and corner areas shall comply with the enhanced uplift pressure requirements of these areas. Fastener densities shall be increased for both insulation and base sheet as calculated in compliance with Roofing Application Standard RAS 117. Calculations prepared, signed and sealed by a Florida registered Professional Engineer, Registered Architect, or Registered Roof Consultant **(When this limitation is specifically referred within this NOA, General Limitation #9 will not be applicable.)**
8. A non-skid surfacing is required for all pedestrian areas, plaza decks or balconies.
9. The maximum designed pressure limitation listed shall be applicable to all roof pressure zones (i.e. field, perimeters, and corners). Neither rational analysis, nor extrapolation shall be permitted for enhanced fastening at enhanced pressure zones (i.e. perimeters, extended corners and corners). **(When this limitation is specifically referred within this NOA, General Limitation #7 will not be applicable.)**
10. All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule 61G20-3 of the Florida Administrative Code.
11. All membranes or packaging shall bear the imprint or identifiable marking of the manufacturer's name or logo and the following statement: "Miami-Dade County Product Control Approved" or the Miami-Dade County Product Control Seal as shown below.
