side-lap and 6" end-laps. Underlayment shall be fastened with corrosion resistant tin-caps and 12 gauge 1 1/4" annular ring-shank nails, spaced 6" o.c. at all laps and two staggered rows 12" o.c. in the field of the roll. Or, any approved underlayment having a current NOA.

fire ratings of this roofing system assembly as well as the location of the fire barrier within

the assembly. See Limitation # 1.

Valleys: Valley construction shall be in compliance with Roofing Application Standard RAS 133

and with Englert's current published installation instructions.

Metal Panels and Install the "Series 1300 Panel" and accessories in compliance with the current published installation instructions and details in Englert's Installation Manual. Flashings,

penetrations, valley construction and other details shall be constructed in compliance with

Roofing Application Standard RAS 133.

Panels shall be installed with approved Panel Clips located at each panel rib side lap spaced at a maximum, listed in  $\bf Table~\bf A$  below, parallel to roof slope, fastened with a minimum of four #10 self tapping pan head corrosion resistant screws of sufficient length to penetrate

through the sheathing a minimum  $^{3}/_{16}$  of an inch.

Standing seams shall be mechanically seamed to a full 1800 degree seam, (double lock).

Valleys: Valley construction shall be in compliance with Roofing Application Standard RAS 133

and with Englert's current published installation instructions.

Metal Panels and Install the "Series 1300 Panel" and accessories in compliance with the current published Accessories: installation instructions and details in Englert's Installation Manual. Flashings,

penetrations, valley construction and other details shall be constructed in compliance with

Roofing Application Standard RAS 133.

Panels shall be installed with approved Panel Clips located at each panel rib side lap spaced at a maximum spacing listed below parallel to roof slope, fastened with a minimum of four #10 self tapping pan head corrosion resistant screws of sufficient length to penetrate

through the sheathing a minimum  $\frac{3}{16}$  of an inch.

Standing seams shall be mechanically seamed to a full 90° degree seam, (single lock).







