| <b>Deck Type 1:</b>       | Steel, Insulated or Non-insulated  |
| <b>System Type:</b>       | Self-adhered sheet applied direct to deck. Mechanically attached overlaying insulation or roof cover.  |
| <b>Air/Vapor Barrier:</b> | Sopravap'r shall be installed with a minimum 3-inch side lap and a 6-inch end lap. Peel the release film back 3 ft and align the membrane to be parallel to the joints. Pull the release film under the membrane as the membrane is applied and secure into place using a heavy roller. Install subsequent rolls of the membrane in the same manner. |
| <b>Surfacing:</b>         | Approved Roof Assemblies over Steel Decking, See Limitation #3   |



## **LABELING:**

All membranes or packaging shall bear the imprint or identifiable marking of the manufacturer's name or logo, city, state and the following statement: "Miami-Dade County Product Control Approved" or the Miami-Dade County Product Control Seal as shown below.



## **BUILDING PERMIT REQUIREMENTS:**

Application for building permit shall be accompanied by copies of the following:

1. This Notice of Acceptance.
2. Any other documents required by the Building Official or applicable building code in order to properly evaluate the installation of this material.

## **GENERAL LIMITATIONS:**

1. Fire classification is not part of this acceptance.
2. This acceptance is for prepared roofing applications. Minimum deck requirements shall be in compliance with the applicable building code. Sopravap'r shall be installed in strict compliance with the applicable building code.
3. Sopravap'r is used as an air/vapor barrier in steel deck roofing assemblies utilizing mechanically fastened overlying components (insulations, coverboards and/or membranes). Steel deck roofing assemblies shall be listed under a current roof covering Notice of Acceptance.
4. Sopravap'r vapor barriers shall be applied to a smooth, clean and dry surface, free from irregularities. Substrate may be primed with an optional layer of Elastocol Stick prior to application if needed.
5. Sopravap'r shall not be left exposed as a temporary roof for longer than 30 days.
6. Sopravap'r shall not be applied over an existing roof membrane as a recover.
